SPECIAL ZONAL CRIME TEAM, CCS, DD, HYDERABAD - NABBED INTER STATE GANG WHO KNOWINGLY PURCHASING STOLEN FOUR WHELEER VEHICLES AND RECOVERED (12) BRAND NEW FOUR WHEELER VEHICLES FROM THEIR POSSESSION – TOTAL RECORVERED PROPERTY IS WORTH OF RS. 3.5 CRORES

Today i.e. on 28.02.2024 the Special Zonal Crime Team, CCS staff conducting vehicle checking at Bahadurpura X roads, Hyderabad, meantime they found one I-20 car without number plate is moving towards Puranapool, immediately CCS Police stopped the vehicle and on seeing police driver of the vehicle tried to escape from the spot, however CCS Police caught hold him and taken him into custody and on enquiry he disclosed his name as A-6 Lavan Kumar, he confessed that while he along with his friends A-1 Karthik, A-2. Shaik Abdullah, A-3 Mohd. Feroz, A-4 Sheik Shahid Ali, A-5 Gandhi Shiva Kumar and A-7 Mohd. Thousif were searching to purchase four wheeler vehicles in OLX, meantime Sonu (A8) Saif Ali Khan (A9) R/o Madanapally and Sayeed (A10) R/o Bangalore approached A1- Karthik over phone and informed that they were having stolen four wheeler vehicles and offered to sell the same for lowest prize. As such A-1 Karthik and A-6 Lavan Kumar and other accused persons hatched a plan to purchase the stolen four wheeler vehicles from them for lowest prize and decided to sell the same to the needy customers for higher prize. Earlier on 20-02-2024, CCS, Police apprehended A-1, A-2, A-3, A-4, A-5 & A-7 and sent them to judicial custody.

Modus Operandi: -

The accused persons A-1 to A-7 formed as a gang and hatched a plan to gain profits by purchasing the stolen four wheelers vehicles for very low cost and decided to sell the same to needy customer for higher price. As per their plan, A-1 to A-7 approached A-8 to A-10 through OLX and purchased the four wheelers vehicles which were stolen at Delhi.

Advice to the Public from Hyderabad City Police: While purchasing the vehicles public has to be check/verify the documents properly and do not purchase the vehicles which is not having proper documents. If any person approached to sell the vehicles with improper documents public has to inform the same to Police by 100 dialling.
