

**BUSTED ONE ORGANIZED CRICKET BETTING GANG – HELD (5) PERSONS – SEIZED  
NET CASH OF RS.15.65 LAKHS AND OTHER INCREMINATING MATERIAL**

On 02-05-2022 during night hours, upon credible information the sleuths of Commissioner's Task Force, Central Zone Team **in joint operation** with Ramgopalpet Police busted one organized Cricket betting gang near Wesley PG College, Sindhi Colony, Secunderabad which is in the limits of Ramgopalpet PS by apprehending (5) accused persons who are organizing Cricket betting which is a Game of chance.

**BRIEF FACTS OF THE CASE:-**

The arrested accused Amit Niranjan Doshi @Amit is a notorious Cricket Betting Organizer who is operating online Cricket Betting throughout India by arranging employees, agents and punters and earning illegal betting money. The remaining accused persons are known persons to him. He hired remaining accused persons on commission basis to organize online Cricket betting. Thus Amit Niranjan Doshi @ Amit had been running cricket betting since last four years with the help of remaining accused persons.

On 02-05-2022, the accused Amit Niranjan Doshi @ Amit was arrested by Ramgopalpet Police Station in Cr.No.114/2022 U/s 3 & 4 of TS Gaming Act-1974. Today i.e. on 03-05-2022 upon credible information the Central Zone Task Force team

apprehended remaining absconding accused persons near Wesley PG College, Sindhi Colony, Secunderabad while they were trying to fled away from Hyderabad City as the main accused was arrested yesterday by Police.

The arrested accused persons along with seized material were handed over to SHO, Ramgopalpet PS for further action.
