

**BUSTED ONE ORGANIZED CRICKET BETTING GANG – HELD (8) PERSONS – SEIZED
NET CASH OF RS.4.5 LAKHS AND OTHER INCREMINATING MATERIAL**

On 02-05-2022 during night hours, upon credible information the sleuths of Commissioner's Task Force, Central Zone Team **in joint operation** with Ramgopalpet Police busted one organized Cricket betting gang beside Prashanth Apartments, Sindhi Colony, Secunderabad which is in the limits of Ramgopalpet PS by apprehending (8) accused persons who are organizing Cricket betting which is a Game of chance.

BRIEF FACTS OF THE CASE:-

The accused Padala Mahesh Babu is a habitual Cricket Betting Bookie & organizing Cricket betting in and around Hyderabad City, he has been in this betting field since last 8 years, in this connection he formed a team with seven members & accepting money from the punters on cricket betting in and around Hyderabad City, during this ongoing TATA IPL-2022 Cricket Season and also during International, Domestic, T20 Series and other benefit matches. For this purpose, he and his team has procured & set up of Online Cricket betting equipment such as Call Connector Box (MOBI AMP 007), laptop and Cell phones inside his car and accepting online cricket betting by using Call Connector/cell phones etc. with the support of his team.

On 02-05-2022 while the accused persons were organizing Cricket betting in a Car bearing TS08HH 0002 (MG Hector) beside Prashanth Apartments, Sindhi Colony, Secunderabad, upon credible information the Central Zone Task Force team apprehended the accused persons and seized the property.

The arrested accused persons along with seized material were handed over to SHO, Ramgopalpet PS for further action.
