### **WEST ZONE TASK FORCE RAIDED ONE PARLOUR – TWO HELD SEIZED HUGE STOCKPILE OF HUKKAH POTS, DIFFERENT TYPES OF HUKKAH FLAVORS, COALS, FILTERS, PIPES, HEATERS**

On 17-05-2023 the Commissioner's Task Force, West Zone team along with staff, on credible information raided Parlor Styled as “**Resto lounge cafe**” at R/o H.No. 10-5-12/2/30, Silver oaks apartments, Masab tank. Hyderabad. And apprehended (02) persons who were illegally running Hookah Parlor at above said premises without valid license and severing to needy customer.

#### **Details of the case:**

On enquiry, Syed Bilal revealed that, Syed Bilal & Syed Abdul Kadhar both are own brothers and decided to earn easy money by providing Hookah to know customers, both are having good knowledge in mixing Hookah for providing the same to customer at “**Resto lounge cafe**” at R/o H.No. 10-5-12/2/30, Silver oaks apartments, Masab tank. Hyderabad. It is also found that Syed Bilal dumped huge quantity of coal, flavors and other Hookah items which are highly flammable in nature and could result in fire accidents, as there are no safety precautions taken. Hence, M Syed Bilal & Syed Abdul

Kadhar are violating the guidelines under COTP Act & Hyderabad City Police Act.

Hence above said accused persons and seized material handing over to SHO Humayun Nagar PS for further action.
