APPREHENDED INTERSTATE OPIUM DRUG TRANSPORTING SMUGGLER/CONSUMER-SEIZED OPIUM WG ABOUT 1400 GMS-WORTH 2.5 LAKH AND 02 CELL PHONES.

This is the case of organized procurement, possession and interstate transportation of Opium drug from Rajasthan to Hyderabad. On 18-05-2023 on reliable information, the Commissioners Taskforce, East Zone Team along with Afzalgunj Police apprehended the accused **1. Hanuman Ram, 2. Chunni Lal** who were found in possession of Opium durg- seized 1400 gms of Opium durg and 02 cell Phones from their instances.

Seized Property.

- 1. Opium – wg about 1400 gms**
- 2. Cell Phones - 02**
All worth Rs. 2,50,000/-.

Accused Details

- 1. Hanuman Ram**, S/o. Bhiya Ram, R/o Qutubullapur, N/o Rajasthan. (**Durg peddler**)
- 2. Chunni Lal**, s/o. Veermaramjee, R/o Trimulgherry, N/o Rajasthan. (**Drug Consumer**)
- 3. Killu**, N/o Pitkashimi, Rajasthan (**absconding**).

Facts of the Case:-

The prime accused by name Hanuman Ram is a native of Rajasthan, he came to Hyderabad and working as a daily labour in a chemical factory at Jeedeimetla, the income earning from his labour works is not sufficient to his desires, in this juncture he came into contact with Chunni Lal who is also a native of Rajasthan and residing in Seunderabad, they both met in Jambeshwar mata Temple, Jeedimetla. Like wise their friendship was established. Chunni Lal is addicted in taking Opium regularly taking the due advantage Hanuman ram hatched a plan to procure Opium from Killu who is a native of Pitkashimi, Rajasthan and professionally opium cultivator. Accordingly Hanuman Ram went to Rajsathan and procure **1400 grms** of Opium for **Rs. 1,18,000/-** and proceeded to Hyderabad and delivered 360 gms of Opium to Chunni Lal at Secunderabad and came to Gowliguda to sell remaining 1040 gms to his known source for which he came to SJD Tea Point, Gowliguda. Acting on tipoff, the Commisioners Taskforce East Zone Team along with Afzalgunj PS apprehended the accused persons and seized opium wg about 1040 grms from Hanuman Ram and 360 gms from Chunni Lal. The above apprhended durg peddler and consumer along with seized opium were handed over to **SHO Afzalgunj PS** for taking necessary action.

The arrests were made under the supervision of **D. Santosh Kumar**, Inspector East Zone Taskforce, **Ravinder Reddy**, Inspector of Police Afzalgunj along with SIs **K. Sanjeeva Reddy, V. Satyanarayana, C. Venkatesh, M. Venugopal, S. Durga Reddy**, East Zone Team and **Afzalgunj** Police.
