# CENTRAL ZONE TASK FORCE RAIDED ONE HOOKAH PARLOUR STYLED AS "DUBAI SHEESHA LOUNGE" AT HABEEB NAGAR, HYDERABAD AND APPREHENDED 16 RESPONDENTS

On the intervening night of 22/23-05-2023, the Commissioner's Task force, Central Zone Team, Hyderabad, on credible information conducted raid on one Hookah Parlor styled as "**Dubai Sheesha Lounge**" which is located at above Hotel Meridian Park, Shop. No. 5-7-568/564/565, near Dargah Yousufain X Roads, Nampally, Hyderabad and apprehended 16 respondents.

- 02) Shaik Ezaz S/o SK Maqdoom, Age:- 21 Years, Occ:- Hookah Center worker, R/o: near Makkah Masjid, Charminar, Hyd., Cell:-8121522802. (Employee at Hookah Centre)
- 03) Shaik Sajeed S/o Shaik Sabeer, Age:-21 yrs, Occ:- Hookah parlour worker, R/o: N S Kunta, Falaknuma, Hyderabad, Cell:-9866898845. (Employee at Hookah Centre)
- 04) and 13 Customers were apprehended.

## Facts of the case:

Brief facts of the case are that the accused Imran R/o Talabkatta (Absconding) is the owner of "Dubai Sheesha Lounge" who is running the Hookah Parlour illegally by serving Hookah pots to the customers and also allowing minor boys to smoke Hookah by violating the rules under COTP Act and gaining illegal profits by charging higher price for Hookah pots and also serving Hookah pots by mixing the Hookah flavors which contain Nicotine as ingredient.

On credible information the Commissioner's Task Force, Central Zone SI of Police, Sri. CH. Naveen Kumar along with team conducted raid on above mentioned Hookah Center and apprehended its employees, customers and seized the following mentioned property.

#### **Property Seized:**

- 1) Hookah Pots- 16 Small & 14 Big, Total=30 Pots
- **2)** Pipes 25
- 3) Al Akber Coal Boxes 72 Small boxes,
- **4)** Chillams 31
- 5) One Register and
- **6)** Cash of Rs.8,880/-.

## Following are the Hookah Flavours

**01)** Two Apples (1) Box, **02)** Kiwi (1) Box, **03)** Night Queen (1) Box & (2) piece, **04)** Orange (1) Box, **05)** Pan Rass (2) Box (Each 1 Kg), **06)** Malai Pan Rass (7) pieces, **07)** Guava (6) Piece, **08)** Water Melon (3) Piece, **10)** Grape ment (1) piece.

The apprehended accused persons along with seized property were handed over to SHO, Habeeb Nagar PS for further investigation. In this case Hookah centre owner Imran R/o Talabkatta is found absconding
