APPREHENDED (02) CHEATERS WHO CREATED FAKE SEVA SAMITHI AND PLANNED TO COLLECT HUGE AMOUNTS

On 23-05-2023 The Commissioner's Task Force North Zone Team along with Police Panjagutta on credible information apprehended (02) accused persons who were created fake 'HARISH ANNA SEVA SAMITHI' and planned to approach famous builders and industrialists with the intention of collecting large sums of money through fraudulent means.

Details of Accused:-

1. **Perala Venkatesh @ Telangana Venkateshwara Rao @ Venkat @ Venkateshwara Rao** s/o. P.Srinivas Rao, age: 26 years, Occ:- Private Business r/o.H.No. Flat No.306 Gayatri Apartments, Bhadurpally, Dundigal, Municipality, Telanagana,
2. **Gaddameedi Rajesh Kumar** s/o.G.Satyanarayana (late), age:42 years, Caste: Goud Occ: Driver r/o.H.NO.150.160, People Plaza, Raja Rajeshwari Colony, Gandimaisamma, Near: Ujwala Bar and Restaurant, Bowrampet, Air Force Academy, R.R District.

SEIZED:-

- 1) One Receipt Book named 'Harish Anna Seva Samithi' with 69 induplicate receipts, -filled 37 receipts remaining unfilled)
- 2) Four Cell Phones (MI-1 NO., Xiami-1 No. I phone-1 No. Poco-1 No.).

Facts:-

The accused A-1 Perala Venkatesh @ Venkat @ Venkateshwara Rao is resident of Bhadurpally, Dundigal, he is usually moves with Sri T.Harish Rao, Hon'ble Minister for Finance and Health of Telangana State. He is well identifies by the persons, business men, social activities who visits Hon'ble Minister. He planned to encash such acquaintance by collecting huge amounts on the name of 'Harish Anna Seva Samithi' for which has printed a colored receipt book titled "HARISH ANNA SEVA SAMITHI" with fake Registration No. 1963/2016. The office address mentioned is 1-126, Vivekananda Colony, Kukatpally, Hyderabad, and the book was printed at Laxmi Printing Press, Shapoor. Without knowledge of one Gundala Mallesh Goud, he shown him as President for above said Seva Samithi with A1 cell number, himself A-1 shown him as Vice-President and his accomplice A2 Gaddameedi Rajesh Kumar as General Secretary. The first page of this fraudulent receipt book falsely states that the Honorable Minister was the first donor, followed by prominent BRS ministers and leaders, Both the accused have planned to approach famous builders and industrialists with the intention of collecting large sums of money

through fraudulent means. On 23-05-2023 on credible information both accused were apprehended by Task Force North Zone along with Police Panjagutta and seized above said material.
