The CC footage of the accused shared with neighbouring PS Nampally and apprehended the accused with in 1 hour with the help of Nampally Police.

In the intervening night of 23/24.05.2023, the accused broke open the lock of Sri Kanakadurga temple and committed theft of Rs 3000/- from the hundi.

Crime No: 161/2023 U/s 457, 380 IPC

In the intervening night of 24/25.05.2023, the accused broke open the lock of Sri Kattamaisamma temple and committed theft of Rs 36,150/- and silver ornaments of wg 70 gms from the hundi of temple.
