Press note

Ahead of the TSLA elections to be held on November 30th , District Election Officer (DEO) Mr. Ronald Rose and City Police Commissioner (CP) Mr. Sandeep Shandilya today briefed Election Commission observers (General ,Police & Expenditure) on the comprehensive measures being undertaken to ensure an incident-free and fair polling day. . The briefing, held at the Telangana State Police Integrated Command and Control Center (TSPICCC), highlighted key strategies.

DEO Mr. Ronald Rose articulated pivotal initiatives, underscoring the integration of advanced technology for surveillance. He delineated the implementation of webcasting, facilitating real-time monitoring of polling stations, and strategically situating micro observers at critical polling stations. The vehicles responsible for transporting Electronic Voting Machines (EVMs) would be equipped with GPS tracking systems, he said.

CP Mr. Sandeep Shandilya shared the detailed security arrangements that will be in place on the polling day. Central Armed Police Forces (CAPF) will be deployed at critical polling stations, bolstered by 391 route mobiles, each comprising 3 armed personnel and 1 PC. Furthermore, 129 patrolling vehicles, 220 Blue Colts, and 122 other vehicles will be on the field to respond promptly to Dial 100 calls and address any incidents that may arise.

He said that a network of 45 Flying Squad teams and 45 Static Surveillance teams, along with static pickets is already operational. Special striking force comprising 28 ACPs and 7 DCP rank officers will be deployed, he informed the meeting. . Nine taskforce team, 9 teams of special forces, and 71 inspectors along with 125 Sub-Inspectors will act as QRT.

Section 144 is in place, people are instructed not to gather. They should leave for their homes after voting.

No Action & under action of police to react to a particular situation will entail severe Action.

All Station House Officers (SHOs) were instructed to remain vigilant and monitor the situation. Minimum One WPC will be deployed at each polling station. This multi-layered security apparatus aims to create a safe and secure environment for voters to exercise their democratic right without any hindrance.

EC observers recommended the deployment of a local individual well-acquainted with the area, ensuring a thorough understanding of the local context. Additionally, their suggestions included the maintenance of hygiene standards at polling stations etc.,

On 07.11.2023 at 18.00 hours received permission from Hon'ble Court in which on 06.11.2023 at 12.30 hours received a complaint from Sri. L. Srinivas Goud S/o Kondaiah, Age. 60 yrs, Occ. Division President (Congress Party), R/o H.No.2-3-677/1, Azadnagar, Amberpet, Hyd-500013 in which he stated that they were canvassing during the election on behalf of and together contesting MLA Shaik Akbar. Specifically, on 06.11.2023, at 09:35 AM, one Mr. Fahad and his henchmen, who belong to the AIMIM Political Party, were creating hurdles and restricting them from canvassing in the area of Pedda Bazar, Indira Nagar, Moosaramabagh Division. They were also threatening them with dire consequences if they continued to canvass in these areas. Additionally, Mr. Fahad and his associates were giving slogans against Mr. Shaik Akber and obstructing any of their followers during their canvassing efforts. Furthermore, they were threatening physical attacks, which posed a significant risk to the contesting MLA Shaik Akber and all of them who were canvassing on behalf of Mr. Shaik Akber from the Congress Party. Therefore, he requested that necessary action be taken against Mr. Fahad and his henchmen according to the law.

Basing on the contents of the above complaint, registered a case in Cr.no. 375/2023 u/s 506, 171(C) r/w 171(F) IPC took up for investigation..

On 07.11.2023 at 18.45 hours received permission from Hon'ble Court in which on 06.11.2023 at 14.00 hours received a complaint from Smt. V. Anusha W/o Arvind. Age. 32 yrs, Occ. Asst. Executive .Engineer , Public Health Department, Hyderabad and attached to Video Surveillance Team of 58 Malakpet Constituency, Hyderabad, R/o Plot No.302, Rajeshwari Enclave, Upperpalli, Attapur, RR Dist and attached to Video Surveillance Team of 58 Malakpet Constituency, Hyderabad, in view of the forthcoming General Elections for T.S. Legislative Assembly 2023. In which he stated that, Today, i.e., on 06-11-2023, she along with her VST team attended duty from 0600 to 1400 hours, and she was assigned to Moosarambagh Division. At about 0930 hours, while she along with FST Team, including videographer, were moving in the Sanjeev Nagar they noticed the Padayatra of Sri Shaik Akber, Contesting Candidate of Congress Party of Malakpet Constituency,. This person had obtained permission for the program from 0700 to 1000 hours from the Concerned Returning Officer. On observation, the above-mentioned person was distributing pamphlets without the name of the Printing Press and Contact Phone Number and No. of Copies printed, which constitutes violation of the Model Code of Conduct Rules. They recorded this incident with video with the assistance of a private videographer, Sri. Syed Munawar Ali. Later she came to Malakpet Police Station and lodged a complaint with a request to take necessary action against Sri Shaik Akber, Contesting Candidate of Congress Party of Malakpet Constituency, for violating the Model Code of Conduct Rules along with two pamphlets as evidence. Basing on the contents of the above complaint, registered a case in Cr.no. 377/2023 u/s 171(H) IPC & Sec. 127(A) R.P.Act took up for investigation.. On 09.11.2023 Malakpet Police served the Notice U/s 41 (A) Cr.P.C to Shaikh Akbar, S/o Shaik Siddique, age. 43 yrs, Occ. Business, R/o Plot No.55 & 56, Abhyudaya Nagar colony, Vanasthalipuram, RR district. N/o Venkatampeta village, Nampally (m), Nalgonda district. Cell No.8008786667, 9052966666 (Contested Indian National Congress Candidate 58-Malakpet Constituency)
