On 26-11-2023 between 1035 to 1105 hrs: Hon'ble Prime Minister of India will proceed to Begumpet Airport from Raj Bhavan, via MMTS, Yashoda Hospital, Rajiv Gandhi Statue/Monappa Island Junction, Right turn Pragathi Bhavan, Begumpet Fly Over, Hyderabad Public School, Shoppers Stop, Under PNT Fly Over, Left turn Airport Y Junction, Begumpet airport.

On 23.11.2023, Sri. V Eswaraiah, Hon'ble XII ADDL Chief Metropolitan Magistrate Nampally, Hyd, has pronounced the Judgment in CC.No. 236/2014 in Cr.No. 108/2013, U/s. 406, 420, r/w 120 (B) IPC of EOW Team 8 CCS, DD Hyderabad., wherein the following accused were convicted:

QUANTUM OF PUNISHMENT:

A-1 Smt. D. Sowdha Kumari, W/o Late Jai Kishan, aged about 49 years, Occ:President Sri Kalki Mahila Mandali)Regd.No. 10697/2000), R/o H.No. 13-2-359/8, Jali Hanuman, Rahempura Police Quarters,Hyderabad – 500026, is convicted for Five years imprisonment and imposed fine of Rs 15,000/-

A-4 Aramalla Anuradha, w/o. John, age 45 yrs, R/o. Flat No. 301, Srinivasa apartments, Kamalanagar, chaitanyapuri, Hyderabad is convicted for two years imprisonment and imposed fine of Rs 5,000/-

A-6 D. Chandrashekar, s/o D. Narsaiah,, age 40 yrs, occ: Business, r/o H.No. 3-6-107, Koratla (V & M), Karimnagar Dist is convicted for two years imprisonment and imposed fine of Rs 5,000/-

A-7 C. Chandrakanth @ chandrakantha Rao, s/o late. C. Venkat Rao, age about 50 years, occ: business, r/o 23-5-710, Lal darwaza, Shalibanda, Moghalpura, Hyderabad is convicted for two years imprisonment and imposed fine of Rs 5,000/-.

GIST OF THE CASE:

This is a case of cheating, criminal breach of trust and conspiracy committed by the accused on the pretext of providing houses and sites collected an amount of Rs. 1.7 crores and thereby fraudulently induced the complainant and others.

INVESTIGATION & PROSECUTION:

Brief facts of the case are that on 21-07-2013 at 12.30 hours the complainant Sri B. Gnaneshwar lodged a complaint stating that, the accused have with pre-planned running a NGO in their locality. Taking advantage of the rapport in the locality, they lured the locality people and their relatives including the complainant, on the name of Rs. 6,00,000/- worth of a new independent house would be provided at lowest price of Rs. 2,00,000/- each, situated in and around of the Hyderabad City, as the accused are getting huge funds from foreign philanthropist who are very much generous to provide low cost houses to the poor and backward people. And to get such house, the accused No.1

and 2 put a condition, that every aspirant of the said low cost house should pay Rs. 35,000/- as advance per house and balance amounts in easy installments. All such propaganda on the name of low cost houses, and collecting of amounts from the public, eventually established fraud, intentional to deceive and defraud for financial gains of the accused.

Sri. V Eswaraiah, Hon'ble XII ADDL Chief Metropolitan Magistrate Nampally, Hyderabad, conducted the trial into the matter. During the Trial, when the Hon'ble CMM, Hyderabad, asked the accused regarding commission of offence, upon that the accused denied the commission of offence and requested to conduct the trial. As, suh, Sri D. Durga Prasad, Hon'ble Chief Metropolitan Magistrate, Hyderabad, has conducted trial and pronounced the judgment on 23.11.2023, declaring that the accused are found guilty sentenced them as follows:

A-1 Soudha Kumari W/o late Jai Kishan, Occ: President Sri kalki Mahila Mandali is convicted for Five years imprisonment and imposed fine of Rs 15,000/-

A-4 Anuradha W/o John is convicted for two years imprisonment and imposed fine of Rs 5,000/-

A-6 Chandra Shaker S/o B. Narasaiah is convicted for two years imprisonment and imposed fine of Rs 5,000/-

A-7 Chandra Kanth S/o Late Sri Venkat rao is convicted for two years imprisonment and imposed fine of Rs 5,000/-.

In this case, total 8 accused were involved. A-2 Srikanth died during trial and trial was conducted splitting the case. As such trial is pending against A-3 Rukmini Devi, A-5 Suneela, A-8 Shiv Narayana vide CC Number 350/2017.

Violation against Model Code of Conduct

Brief facts of the case:

This is a case wrongful restraint, public nuisance and violation of Model Code of Conduct, wherein the accused persons in IDH colony, 62- Sanathnagar constituency indulged in affixing the flexi of BRS party. On 22-11-2023 there is a BRS door to door campaigning program in which Minister Sri Tallasani Srinivas Yadav Garu is going to participate in the program at IDH Colony wherein, one BRS Flexi of Sri Tallasani Srinivas Yadav was affixed to the Rajiv Gandhi Statue which violated the rules of Model Code of Conduct (MCC) as well as instructions given by the Returning officer. This incidents occurred on 22-11-2023 around 1630 to 1700 hrs at following place IDH Colony, New Bhoiguda, Hyderabad, falling within the jurisdiction of Gandhi Nagar Police Station, Hyderabad on the complaint of Smt N Parvathi, Occ. Asst. Training officer Department of employment and training, Hyderabad and attached to flying squad Team of 62 Sanathnagar Constituency, Hyderabad case was registered in Cr. No 305/2023 U/s 4 of TSPDOPPOOPA Act . During the course of the investigation examined the eye and independent witnesses basing on the statements of witnesses the prima facia established against the respondents below mentioned,

Today issued 41 (A) Cr.PC notices to the above said accused persons and instructed them to appear whenever their presence is required before the investigating officer or the Hon'ble Court.

No 307/2023 U/s 4 of TSPDOPPOOPA Act & 188
