CREATED PUBLIC NUISANCE AND VIOLATED THE “MODEL CODE OF CONDUCT” AT AUDAIAH NAGAR OF P.S MARKET.

FACTS OF THE CASE:-

The In-charge FST-2A (Flying Squad) of Sanathnagar-62 A/C Sri. Abdul Shafi S/o Abdul Shaheed, Age: 50 yrs, Occ: A.O HMDA, Ameerpet, Hyderabad, R/o Tolichowki, Hyderabad, # 9440422861, along with his team while performing the duty on 26.11.2023 at about 2245 hours, received a credible information that there was huge gathering near the residence of Sri. T. Padma Rao Goud, Contested candidate for MLA of Secunderabad-70 Assembly constituency. Immediately the above Flying Squad and Police Market P.S. rushed to spot and found huge public gathering about 150-200 members at residence of Sri. T. Padma Rao Goud, Audaiah Nagar, Sec-bad, some of them wearing BRS scarf and were sitting inside, on seeing them, they run away and sped from the spot. The above said persons, without having any prior permission from the concerned Returning Officer, gathered there and there by created nuisance as well as violated “Model Code of Conduct” in view of upcoming TSLA-2023 Elections. As such the In-charge FST-2A (Flying Squad) of Sanathnagar-62 A/C Sri. Abdul Shafi lodged a complaint before Police Market P.S.

Basing on his complaint, a case was registered in P.S Market and investigation into.

During the course of investigation, I.O examined the witnesses and recorded their detailed statements as per sec 161(3) Cr.P.C, which corroborated the contents of the FIR. The IO also verified videography, available, showing the incident. It also established the prima facie of the offence. As per the investigation, the notices U/s 41-A Cr.P.C were issued to 1) Sri. T. Padma Rao, 2) T. Kiran Kumar Goud 3) T. Kishore Kumar Goud, 4) Bhuvangiri Kiran Goud, 5) M. Dinesh 6) Baldev 7) M. Maisaiah, for furtherance.

POLICE ASIF NAGAR APPREHENDED THE ACCUSED INVOLVED IN A WOMAN MODESTY CASE.

This is a case of a violation of the Model Code of Conduct and assaulted women wherein the accused

persons, namely:

1. Mohd Moosa, son of Mohammed Mehmood, aged 42 years, occupation: Business, residing at

H.No.12-2-389/55, Ali Nagar, Maqbera, Asif Nagar, Hyderabad.

2. Syed Sikandar, son of Late Syed Khasim, aged 39 years, occupation: Manager at Vintage Palace,

residing at H.No.12-1-558/6, Syed Ali Guda, Asif Nagar, Hyderabad.

3. Mohammed Aleem, son of Mohammed Abdul Waheed, aged 43 years, occupation: Supervisor,

residing at H.No.12-2-360/1/C, Syed Ali Guda, Asif Nagar, Hyderabad.

4. Hasin Bin Gafoor, son of Gafoor Bin Abdullah, aged 44 years, occupation: Real Estate, residing at

H.No.12-1-523/5, Syed Ali Guda, Saber Nagar, Asif Nagar, Hyderabad.

These individuals assaulted a woman named Smt Anjum Begum, wife of Shaik Waleed, aged 30 years,

occupation: Pvt Job, residing at IAS Colony, Tolichowki, Hyderabad. Smt Anjum Begum is an

Independent candidate contesting from Nampally Constituency in connection with the upcoming TS

Assembly elections-2023. The incident took place during a motivational program at Arabgalli, Murad

Nagar on 26.11.2023 at 13:00 hours. The accused persons assaulted on her and also took away a net

cash of Rs 15,000/- and an iPhone 11 mobile phone while she was trying to call the police. They beat

her and locked her in a closed room. As such, they violated the rules of the Model Code of Conduct.

Upon receiving the complaint, Police Asif Nagar registered a case under

Cr.No.405/2023 U/s 342, 354,

356, 379, 506, 323, 171C(2)(a) r/w 34 IPC of PS Asif Nagar, Hyderabad and initiated an investigation.

On 26.11.2023, Police Asif Nagar took the aforementioned accused into custody and issued a notice

under Section 41(A) Cr.P.C, instructing them to appear before the Investigating Officer or the Hon'ble

Court whenever summoned.

It is warned that individuals should not indulge in any cognizable offense, create any public

disturbance, and must maintain public peace and tranquility in the Nampally Assembly constituency

segment during elections.

The investigation is proceeding under the supervision of Sri B Balaswamy, IPS, Deputy Commissioner

of Police, South West Zone, and the guidance of Sri L Raja Venkat Reddy, Assistant Commissioner of

Police, Asif Nagar Division, Hyderabad.

CRIME NO.431/2023 U/S 427, 171-C, 171-F, 147, 341, 323 R/W 34

IPC REGISTERED AT SAIDABAD PS

This is a case of mischief, voluntarily interferes with the free exercise of electoral right commits the offence of undue influence at an election, rioting, wrongful restraint, voluntarily causing hurt, and acts done by five MIM Party supporters in furtherance of common intention.

BRIEF FACTS: The brief facts of the case are that on 27-11-2023 at 00:45 hrs received a Telugu written complaint from Sri Mohd. Saleem S/o Mohd. Yousuf, age:33 yrs, Occ: Auto Driver, R/o Singareni Colony, Saidabad, Hyderabad wherein he stated that on 27-11-2023, at around 00:15 hrs, he picked up passengers at Dabeerpura and dropped them at Saidabad X Roads. Later, while he was returning to his house in Singareni Colony, a person known by the name Rizwan, R/o Sapotabagh, Saidabad, Hyderabad, stopped his auto and slapped him for carrying an MBT Party flag on his auto. Additionally, four others chased him and stopped him at Hanafia Mosque, where they proceeded to beat him. He has requested necessary action be taken as per the law.

During the course of the investigation, today i.e., on 27-11-2023 received credible information that the accused persons involved in the above offence were at Sapotabagh. Immediately, Saidabad Police went there and apprehended the accused 1) Mohd. Rizwan, S/o Late Mohd Rasheed, Age: 34 years, Occ: Software Employee, R/o: H.No. 16-2-750/3, Sapotabagh, Saidabad, Hyderabad 2) Mohd. Khadeeruddin, S/o Late Rafiquddin, age 23 yrs, Occ: Auto Driver, R/o H.No.16-2-748/48/A, Sapotabagh, Saidabad of MIM Party supporters. They were taken into custody and brought to the police station. However, Akram and two other accused have been absconding since the date of the offence. In this case, a two-wheeler motorcycle bearing No.TS11EU3966 which was used in the commission of the offence was seized from the possession of accused Mohd. Khadeeruddin under the cover of confession cum seizure panchanama.

The apprehension of the accused persons was made under the supervision of Sri. B.Rohith Raju, IPS, DCP, South-East Zone, Hyderabad, Sri D.Venkanna Naik, Asst Commissioner of Police, Saidabad Division, Hyderabad City, by Sri Raghavender, Station House Officer, PS Saidabad, Kum.Mamatha, Sub-Inspector and staff of PS Saidabad. Sri B. Rohith Raju, IPS, DCP, South-East Zone appreciated the good work done by the officers of Saidabad of PS Saidabad.
