APPREHENDED OF THREE ACCUSED PERSONS WITH INTENTION TO CONDUCT

BOGUS VOTINGSON TSLA-2023 ELECTIONS OF HABEEBNAGAR POLICE STATION.

The Habeebnagar Police with assistance of DCP,Task Force and her teams of South West zone have apprehended three accused persons who are with the intentiondof conducting bogus voting in the TSLA-2023 elections. Accused persons were foundaremoving indelible ink marks from voters who had already cast their yotes with theheln of an unknown chemical. The three accused individuals, identified as Mohd Zakir,Mohd Shabuddin, and Ritesh Gupta, have been caught in possession of materials andregistered a Cr. No. 336/2023, U/s 171(D) r/w 171(F),419,468,471,474 r/w 109IPC under multiple sections of the Indian Penal Code and the R.P. Act. The case ishunder investigation for collection of more evidences.

The accused individuals had planned to carry out bogus voting on polling dayaand at Police Station No. 123 of Govt High School Telugu Medium Nampally hadapurchased materials to remove indelible ink marks from casted votes. They hadidentified a religious place, a shutter under the premises of a

mosque, to conduct theiractivities. As per their plan they produced voters I.D. Cards of different from who were aabsent, died and shifted..

The police seized voter lists, duplicate voter ID cards, unused cotton, a chemicalabottle, a mini slip printing machine, and paper rolls from the accused individuals. Theaccused individuals had collected the voter list and had identified unknown personswho had vacated their homes. They had used their

voter ID numbers to print outinformation slips and had planned to conduct

bogus voting with the help of outsidepersons...

The three accused individuals were arrested by Sri Rambabu, SHOHabeebnagar PS with the support of Sri Srinivas, Inspector, Taskforce and hisSri Raja Venkat Reddy, ACP Asifnagar and with theteam under the supervisionguidance of Smt Nitika Pant, IPS, DCP Taskforce and Sri B Balaswamy, IPS DCP South West Zone.

The police have taken strict action against the accused to ensure that the elections are conducted without any fraudulent activities.
