BUSTED ILLEGALLY MANUFACTURING DUPLICATE/ ADULTERATE/SPURIOUS MATERIAL - APPREHENDED 03 ACCUSED PERSONS.

The sleuths of Task Force, Central Zone team along with staff of Kachiguda PS on credible information laid a trap near **Kumar Theatre, in the limits of Kachiguda PS**, apprehended accused Mahendra Singh R/o.Nagaram N/o.Rajasthan State. He is illegally procuring and selling general store duplicate/Adulterate/Spurious Coconut Hair oil on the brand name of Parachute, duplicate Detergent powders on the brand name of Surf Excel, Wheel and other duplicate floor cleaning liquids on the brand name of Lizol, Harpic and spurious/Adulterate tea powders on the brand name of Red Label, Brook bond , Spurious Masala powder on the brand name of Everest etc. On lead with the assistance of Authorised representative of Marico Limited and Hindustan Unilever Limited and PNG Ltd conducted simultaneous raids at 3 places in the limits of **Nagaram, Keesara Mandal** (Rachkonda), **Katedhan industrial area** in the limits of Mailardevpally area (Cyberabad) wherein the accused along with others illegally established manufacturing, packing units. Apprehended (03) ACCUSED PERSONS along with one boy juvenile and seized huge quantify of duplicate raw material, spurious/adulterate food material, packing, sealing machines etc.

➤ **Brief Facts of the case:**

Accused Mahendra Singh is native of Rajasthan State and residing in the limits of Nagaram and running Kirana & Genral trading. To gain easy money illegally he along with Shaym Bhati, Kamal Bhati both are resident of Kachiguda N/o. Rajasthan State along with their associate Jairam R/o. Begum Bazar are organizing illegal business by installing machinery equipment and indulging in preparation of duplicate Hair oil, duplicate Washing powders, washing Detergent soaps, Cleaning liquids, Spurious /Adulterate Tea powders , Masala powders by violating Copy Right Act, in cheating manner selling above material to various kirana shops, super markets as genuine products in and around Hyderabad City and earn easy money illegally.

The kingpin of the racket 1)Mahendra Singh, 2)Shyam Bhati, 3)Kamal Bhati & 4) Jairam are purchasing duplicate branded food products, low quality raw material and brand lables, boxes, stickers, empty bottles, packing boxes from Gujarath, Bangalore, Delhi and indulged in preparation and adulterating food items, eatable oil, tea powder, soaps and regular general store items. The duplicate items were stored at Outskirts of warehouse at Nagaram, Katedan and the same are selling away in super markets, kiran stores, merchants through distributors and agents on commission basis. Organizers have been engage non local labour of Bihar State for preparing, manufacturing and packing duplicate material and reputed brand stickers paste on material.

The accused persons are selling the products as genuine products on low price on the MRPS and cheating customers by violating Copy Right Act. The spurious/Toxic material which may cause life threatening effects even in small amounts and with short exposure. May cause serious and prolonged health effects on short or long term exposure to human. In this case Organizers namely Shyam Bhati, Kamal Bhati & Jairam are absconding.

On 22-02-2024 a case has been registered against accused persons vide **Cr.No.76/2024**, U/s. 272, 273, 420 IPC & Sec. 63,65 of Copy Right Act of Kachiguda PS.
