BUSTED ILLEGALLY SALE OF NARCOTIC MATERIAL - APPREHENDED (03) ACCUSED PERSONS.

The sleuths of Task Force, North Zone team along with staff of Begumpet PS and Drug Control Administration on credible conducted a raid on Mahaveer Medical Shop, Begumpet where selling Narcotic Drugs illegally at exorbitant prices to drug addicts, seized Nitrovit, Codeine etc, and apprehended (03) accused persons.

➤ **Details of apprehended accused persons :-**

- **Mutha Kishore Kumar** s/o late.M.Madanlal, age: 58 years, r/o. Marredpally.
- **Muslam Raju** s/o Muslam Saranappa, age: 39 years, r/o.Begumpet.
- **Ireni Ramesh Goud** s/o I.Kesha Goud, age: 30 years r/o.Bowenpally.

➤ **Brief Facts of the case:**

The accused Mutha Kishore Kumar is resident of Marredpally and had been engaged in Medical field since 20 years. He is running Mahaveer Medical Shop, Rasoolpura, Secunderabad without qualification and knowledge of medical field. The said shop is registered on the name of Avinash Bollineni, but he never runs the shop. The accused Mutha Kishore Kumar selling Scheduled H1 Drugs like Nitravet etc., without Doctors Prescription to needy customers at above said Medical Shop illegally at exorbitant prices to drug addicts with the help of his assistant Muslam Raju.

On enquiry Mutha Kishore Kumar disclosed that he was buying such Narcotic medicines through Ramesh Goud, Medical Representative. Immediately, Ramesh Goud was also apprehended, on further enquiry Ramesh Goud revealed that he used to supply such material to Mutha Kishore of Mahaveer Medicals, Begumpet with duplicate bills. Recently he purchased 260 bottles of Magnatuss-T - Cough Syrup (**Codeine Phosphate & Trprolidine Hydrochloride Syrup**) at P.S Global Agency and supplied to Mutha Kishore Kumar with intention to get high profits.

In this regard a case has been registered against accused persons vide Cr.No.154/2024 U/Sec. 8© r/w.22 (b) of NDPS Act of Begumpet PS.
