### **BUSTED ACCUSED WHO IS TERMINATING THE INTERNATIONAL INCOMING CALLS INTO LOCAL CALLS THROUGH INTERNET USING VOIP (VOICE OVER INTERNET PROTOCOL) EQUIPMENT**

The sleuths of the Commissioner's Task Force, **South Zone Team**, along with the **Telephone Department Officials and Santosh Nagar Police, Hyderabad** have apprehended (02) accused persons who are running the illegal Call Routing under the limits of Santosh Nagar and Balapur by Terminating the International Incoming Calls into local calls through Internet using VOIP (Voice Over Internet Protocol) equipment, thereby impersonating and cheating the Government of India and causing huge financial loss to the Department of Telecommunications for their illegal gain, which is also posing a threat to the National Security. The said Termination of calls or routing of calls is not permitted by DOT (Department of Telecommunications), Government of India.

#### **Brief Facts and Modus Operandi:-**

On credible information, the Commissioner's Task Force, South Zone Team, Hyderabad along with Telephone Department Officials and Santosh Nagar Police conducted raid at Door No. 18-1-350/11/92, Poolbagh, Hyderabad where the accused person by name **Hidayath Ali** is found running an illegal International Telephone Exchange by using an Internet connection, SIM BOXES's and with BSNL SIMs at Door No. 18-1-350/11/92, Poolbagh, Hyderabad and on his lead we have conducted another raid at Door No. 9-140/10/B, Flat No. 204, Metro Apartment, Balapur, with this setup **the calls from Foreign Countries (Dubai, Qatar, Saudi etc.) are being terminated in India by passing illegal ILD exchanges.** The CLI ( **Calling Line Identification** ) displayed to Indian citizens will be the mobile numbers of India. Such calls cannot be back-traced by Law Enforcement Agencies, thereby causing grave threat to National Security. This illegal setup is causing huge revenue loss to Govt. exchequer and Indian Telecom Service Providers while the accused is gaining economic advantage for himself dishonestly through fraudulent means. Further, the accused is conspired with another accused by name **Mujahed Ahmed**.

Commissioner's Task Force, South Zone Team, Hyderabad have apprehended the accused **1) Hidayath Ali and 2) Mujahed Ahmed** and conducted raids simultaneously along with DOT Staff at Edi Bazar, Phoolbagh and Balapur area under the limits of Santosh Nagar and Balapur PS respectively and seized the above said objects.

In this regard, a case has been registered in Cr.No.70/2024 U/s 406, 420 IPC & Sec.4, 20, 21 and 25 of ITA, Sec.3 & 6 of IWTA-1933 and Sec. 66 C, 66 D of IT Act of Santosh Nagar Police Station, Hyderabad and took up investigation.

### **BUSTED RIPENING FURITS BY ARTIFICIAL PROCESS IN VARIOUS PLACES IN HYDERABAD - SEIZED ARTIFICIALLY RIPENED MANGOES, CARBIDE AND ETHYLENE**

The Commissioners Task Force, Hyderabad City, on credible information Conducted raids along with Food Safety officers of GHMC and Concerned Police Stations on various fruits warehouses and stalls located in Hyderabad City and sized huge amount of Artificially ripened Carbide and Ethylene which are used to Ripen Mangoes artificially.

#### **BRIEF ABOUT CASE:**

The Commissioners Task Force, Hyderabad City Along with Food Safety officers raided Warehouses and various stalls in Hyderabad which were Selling and Suppling Artificially ripened Mangoes. They used to supply the fruits to different fruit shops and Juice centers in Hyderabad city. Due to heavy demand for fruits enlighten the current

holy month of Ramzan and marriage season, They are using artificial ripeners like Ethylene and Calcium Carbide/ Calcium Acetylide to bring unripe fruits especially mangoes into the market by breaching the FSSAI guidelines. They are using illegal methods of storage and ripening mangoes which are dangerous to humans causing serious effects to public health like respiratory and skin ailments. When used the excessive quantities, these Chemicals can causes severe health problems like Skin Burns, Skin Irritation, Inflammation, Lung Irritation when inhaled, arsenic in mangoes will cause heavy metal poisoning and others neurological disease. The respondent intentionally using harmful Chemical substances illegally for his personnel gain by cheating the innocent public and violating FSSAI Guidelines.

In this regard cases have been registered in various Police Stations.

### **BUSTED ORGANIZED CRICKET BETTING RACKET- 03 HELD**

On credible information the sleuths of Commissioner's Task Force, Central Zone Team busted organized cricket betting racket and apprehended (3) accused persons namely 1)Uday Simha Reddy 2)Mohd Faheemuddin & 3) M. Bhanu Prasad at parking place of Sweekar Hotel in the limits of **Sultan Bazar PS** who have been organizing & accepting Cricket betting from various punters for ongoing Legends Cricket Trophy,2024 in-between New York Superstar Strikers vs Rajasthan Kings Final match held at Pallekele International Cricket Stadium and gain easy money illegally.

#### ➤ **BRIEF FACTS :-**

Accused persons B.Uday Simha Reddy, MD.Faheemuddin, M.Bhanu Prasad are residing in the limits of Dilsuknagar, Hyderabad. They got knowledge about online cricket betting system. Their incomes are not sufficient to spend lavishly.

To gain easy money illegally through betting, through known sources obtained betting app IDs & passwords of [www.happybetplay.com](http://www.happybetplay.com) & [www.happycricket.com](http://www.happycricket.com) and installed in their laptops and organizing cricket betting. They have been accepting betting amount from various punters and sharing betting IDs, accepting betting amount through Google Pay, PhonePe. Sometimes their collection agent M.Bhanu Prasad directly collecting betting amount from punters.

On 19-03-2024 evening hours the accused persons while accepting betting amount for ongoing Legends Cricket Trophy,2024 held in-between New York Superstar Strikers Vs Rajasthan Kings Final match meanwhile on tip off caught them and seized above material from their possession.

The apprehended (3) persons 1)Uday Simha Reddy 2)Mohd Faheemuddin 3) M. Bhanu Prasad along with seized material were handed over to SHO Sultan Bazar PS for taking necessary action.

The apprehension was made under supervision of **Ms. S.Rashmi Perumal, IPS, Dy. Commissioner of Police, Task Force, Hyderabad**, by Sri.N.Ramakrishna, Inspector of Police, Ch. Naveen Kumar SI of Police and staff of Central Zone Task Force, Hyderabad.
