

PRESS NOTE GOPALAPURAM POLICE NABBED (01) ACCUSED PERSON INVOLVED IN THE GANJA CASE.

On 26.03.2024 in the Night hours, Gopalapuram police staff received credible information regarding accused and apprehended accused person near Padmaja Hotel, situated opp. to Secunderabad Railway Station and on enquiry the voluntarily confessed his guilty in this case. As per the confession of accused the Gopalapuram Police staff seized 5 KGs Ganja worth Rs 1,25,000/- and one mobile phone of Model Infinity Note 12 worth Rs 3000/-.

Accused Details:

A1) Bullu, R/o: Bhanjanagaram village, Odisha, (Absconding)

A2) Jitendra Nahak S/o Ramesh Chandra Nahak, Age: 27 years, Occ: Swiggy Delivery Boy, R/o H NO 2/40C/5, Beside RB Hotel, Izzath Nagar, Kothaguda, Hyderabad, N/o Kodala Village and Tehsil, Ganjam District, Odhisha State, Pin Code 7601032, Cell: 7043844905 (**Drug Peddler**)

SEIZURE:

- 1) Ganja weighing 5 Kgs of Ganja worth Rs 1,25,000/-
- 2) One mobile phone of Model Infinity Note 12 worth Rs 3000/-

FACTS OF THE CASE:

The accused Jitendra Nahak is native of Ganjam District, Odhisha State and 8 months back the accused came to Hyderabad for eking his livelihood and due to bad companion he got information that his friends are buying the ganja for fewer prices and selling the same to needy customers and earning huge money. As the sale of Ganja is banned in Hyderabad city, so he thought he can earn more money illegally in a short span to fulfill his lavish expenses. As per his plan 24.03.2024 Jitendra had boarded train from Secunderabad Railway Station, got down at Brahmapur Railway Station, later took bus and went to Bhanjanagaram village. While he was looking for Ganja he noticed one person with ganja. Immediately he approached him and introduced himself and asked for Ganja. He had said that his name is Bullu and he sells 1 Kg of Ganja for Rs 4000. On which Jitendra had purchased 5 Kgs of Ganja for Rs 20,000 and he planned to sell the same to the needy customers in Hyderabad for Rs 7000 per Kg. Jitendra had packed the Ganja in 3 packets wrapped with paper and covered with brown tape. In which two packets were weighing 2 Kgs each and one packet was of 1 Kg. On 26.03.2024 in the evening hours Jitendra came to Secunderabad Railway Station area to sell the Ganja and while he was waiting near Padmaja Hotel, Secunderabad to sell the ganja packets to the needy customers, in meantime they intercepted them and caught hold Jitendra and seized the same

MODUS OPERANDI:

The accused person bought 5 KG Ganja from the Absconding Accused Bullu at Bhanjanagaram, Odhisa State and came to Secunderabad to sell the same to Needy customers and to earn huge money illegally in a short span to fulfill his lavish expenses.

ARREST:

The arrest was made under the supervision of Sri P. Ashok, Addl. DCP, North Zone, Sri P. Subbaiah, ACP Gopalapuram, by Sri P Srikanth Reddy, SHO, Sri BV Kausheek, Addl-Inspector of Police and Sri G Rama Krishna, SI along with Staff of Gopalapuram Police Station.

GOPALAPURAM POLICE NABBED (07) MEMBERS OF GANG of CELLPHONES SNATCHING AND RECOVERED SIX MOBILE PHONES & ONE AUTORICKSHAW.

On 26.03.2024 Gopalapuram Police nabbed an (7) members gang of cell phones snatchings. The gang consisting of two accused persons **A-1. Kante Jhonson** @ **Kongti Johnson and A-2. Mohd Sohail** and 05 CCL's while conducting vehicle checking at Chilkalguda X Roads, Gopalapuram, Hyderabad and recovered one Auto Rickshaw vehicle and Six mobile phones from the possession of the accused persons.

DETAILS OF THE ACCUSED PERSONS:

- **A-1**. Kongti Johnson, S/o. K. Sunil, Age: 20 yrs, Caste: SC (Madiga), Occ: Centring Work, R/o. Near Govt School, Hanuman Nagar, Jagathgirigutta, Hyderabad
- **A-2**. Mohd Sohail, S/o. Mohd Sayed, Age: 20 yrs, Occ: un employee, R/o. 4-39-116, Hanuman Nagar, Road No. 10, Jagadgirigutta, Hyderabad

And 5 CCL's

CASES DETECTED:

Cr. No 115/2024 U/s 395 IPC and 102 CrPC of PS Gopalapuram

SEIZURE:

- 1. Cell Phone make Redmi, Model Note 7 Pro (Pertains to this case)
- 2. One auto (used in the commission of offence)
- **3.** 05 cell phones which were stolen and snatched at various places of Hyderabad and Cyberabad limits.

PREVIOUS HISTORY OF THE ACCUSED PERSONS:

The accused person **A-1. Kongti Johnson** having criminal history, was involved in a case vide Cr. No 873/2021 U/s 363, 354 D IPC and Sec 7 R/w 8 of POCSO Act 2012 of Jagathgirigutta PS.

FACTS OF THE CASE:

On 23-03-2024 at 1000 hrs received a telugu written complaint from Sri Roshan Kumar Gupta, Age: 20 yrs, Occ: Cook at Pista House, SD Road, Secunderabad, N/o. Koldiya, Giridi Jilla, Giridi, Jharkand in which he stated that he has been residing at Nikhil Hostel, Monda Market and working as cook at Pistha House since 2 years. On 23.03.2024 at about 1:20 AM, after the completion of his work at Pistha House, while going to his Room by walk via Clock tower, Secunderabad. At about 1:30 AM, when he reached near Centenary Baptist Church, Secunderabad, in the meantime the accused persons in an unknown Auto Rickshaw came from backside and one of the person who sat in back Seat has snatched his REDMI Note 7 Pro, Mobile Phone worth of Rs. 5,000/- from his Right hand and sped away towards railway station, Secunderabad. The Complainant tried to chase them but he couldn't catch them. Further, complainant informed that he can identify the said person if he sees him again. Complainant came to PS Gopalapuram and lodged a complaint and requested for necessary action. A case in Cr. No. 115/2024 U/s 392 IPC was registered at Gopalapuram Police Station and investigation too.

INVESTIGATION:

While the efforts were in process, on 25.03.2024 at about 2330 hours the Gopalapuram crime team apprehended 7 members gang including 5 CCL's while conducting vehicle checking at Chilkalguda X road, who were moving in suspicious manner in a Stolen Autorickshaw and recovered one Autorickshaw and six mobile phones from the possession of the accused persons. On thorough interrogation, they confessed that they have committed the offences in the intervening night of 22/23.03.2024 at the following places 1. Near to Clock Tower, Secunderabad, 2. Bowenpally, 3. Balanagar, 4. Fatehnagar Bridge, 5. Balanagar & 6. Begumpet.

The accused persons along with CCL's are habituated to earn easy money by committing theft of Mobile phones from gullible people by causing hurt to them. They all gather at a place select an area in the night hours and target a person who is moving alone in isolated areas. Further will try to snatch mobile phones from them and in this process if they resist then they beat them and will commit theft of the phones. They have committed the offence by using the stolen autorickshaw in this case which they have stolen before committing the cell phone snatchings.
