

PRESS NOTE SHE TEAMS HYDERABAD

Hyderabad, May 2, 2024

The SHE Teams Hyderabad continue their commitment to ensuring the safety and security of women and combating harassment and other forms of crime.

1. XI SPECIAL METROPOLITAN MAGISTRATE.

Petition No. 289/2024: One individual was presented before the court and charged under the appropriate legal provision. The court sentenced the individual to **6 days of simple imprisonment and imposed a fine of ₹200.**

2. 1ST SPECIAL METROPOLITAN MAGISTRATE.

Red-Handed Cases: 5 individuals were caught red-handed and presented before the court. Each was sentenced to **2 days of simple imprisonment and fined ₹200/-**

3. In an additional case, one individual was presented before the court. They were sentenced to 5 days of simple imprisonment and fined ₹200.

4. The SHE Teams Hyderabad have received a complaint against an advocate and former government pleader, Mr. A. Sanjay Kumar. The complaint alleges that Mr. Sanjay Kumar has been misbehaving with the complainant within court premises, forcing her to provide sexual favors, stalking her on a daily basis, and blackmailing her using his influence. Upon receiving the complaint, the SHE Teams immediately launched an investigation into the allegations. The complainant's safety and well-being are our top priority, and we are providing support and legal advice to ensure her rights are protected.

An FIR has been Registered against sanjay kumar in Crime No 97/2024 354,354D,506 IPC at charminar, which is investigating the allegations and working to gather evidence and witness statements. The SHE Teams Hyderabad are closely monitoring the case and providing support to the complainant to ensure justice is served.

Brief facts of the case: on 27-04-2024 at 21:30 hours received an English typed complaint from Sri Mohammad Abdul Jaleel S/o Mohammad Usman Miya, age: 44 years, Occ: Business, r/o H.No.10-1-38A, Power House Basthi, Main Hospital Area, Kothagudem, Khammam, Telangana, Cell No.9949906428 stating that on 25-04-2024 at about 21.35 hours, he was standing at Nayapool X Roads to go towards MGBS, meantime one auto came to him consisting auto driver one more person sat beside him and in back

seat two persons were there. Later auto driver asked him that where he has to go and he told him that he is going to MGBS, upon which he asked him to sit in auto and he sat left side in back seat of auto and beside him already two persons were there. The auto was waiting for some time and in the meantime two persons came to auto and discussed with auto driver and after few minutes the auto started. After crossing Minar Garden function Hall who sat behind him he asked the auto driver that “mery pass sey Rs.80/- liye aur main kyon ithna tight baitu” then the auto driver stopped auto and asked him to come front side to sit and he got down from auto. On that the auto driver fed away with his auto along with those persons. He got confused and checked pockets of his Kurtha and he came to know that his cell phone VIVO Y 51 was missing, he suspect that the persons who sat in the auto committed theft of his said cell phone, with this incident he was in fear and he went to MGBS in Seven seated auto and went to his native place Kothagudem. On 26-04-2024 at about 10.30 hours he blocked his Phone no.9949906428 and took new SIM of Airtel and took same phone no. 9949906428 and after activation he received the messages to mail address jaleelmohammed6666@gmail.com that the amount of Rs.20,000/- was drawn from my bank account No.62434111264 of SBI Bank, Kothagudem Branch, Telangana, through UPI in trenches on 25-04-2024 to 26-0-2024. Today, he came to Police Station from Kothagudem to lodge the complaint. Hence, he requests the kind officer to take necessary action.
