NABBED ONE FAKE DOCTOR WHO PRETENDING HIMSELF AS DOCTOR AND PROVIDING TREATMENT TO INNOCENT PEOPLE

On 02-05-2024, on credible information the Commissioners Task Force, East Zone team along with Amberpet Police, apprehended one fake doctor who pretending himself as doctor and providing treatment to innocent people without possessing any valid Degree from the competent authority thereby earning easy money illegally.

➤ **Accused Details:**

1) Raju Gangaram Ankalap, Age:53 Years, Occ: Fake Doctor, R/o Srinivasapuram colony, Ramanthapur, Hyderabad.

➤ **Seized Material:**

- 1) Prescription in his own hand writing
- 2) Stethoscope
- 3) Blood Pressure Checking Machine
- 4) Sugar Testing Machine
- 5) Various Powders
- 6) Clinical Agreement Paper
- 7) Letter Head
- 8) Mobile Phone One Plus

Previous Cases:-

- 1) Cr. No 215/2023, U/s 419,420 IPC of PS Amberpet, Hyderabad

Facts of the Case:-

The accused is a native of Ahmadabad, Gujarat, and he studied Diploma courses in Yoga & Naturopathy and Emergency Medical Services, at Ruby Hall Clinic Hospital, Pune, while so he acquired clinical and medical knowledge, later in the year 2019 he was migrated to Hyderabad and started clinic as "Sri Sai Venkateswara Clinic" at New Patel Nagar, Amberpet, Hyderabad and displayed board as Dr Ankalap Raju, D.N.Y.S., P.G.D.E.M.S (Mumbai) & Family Physician, he observed the innocence of patients of the Amberpet, Ramanthapur locality, to earn easy money he hatched a planned to provide the allopathic treatment without possessing any valid degree or certificate from the competent authority. In the recent past, he was arrested twice by police in a similar case. However, he did not mend his attitude and again opened a clinic and provided allopathic treatment by prescribing the allopathic medicines and administrating the injections, saline etc., negligently and playing with the lives and limbs of the innocent patients.

On credible information on 02-05-2024, the accused was apprehended by Commissioners Task Force, East Zone Team along with Amberpet police and seized incriminating material from his possession.

An important appeal to the people is to be aware towards choosing the doctors for treating their ailments, and also suggesting not to approach the doctors/medical practitioners who don't possess valid degrees.

Today (03.05.2024) from 06.30 AM onwards, CP, Hyderabad along with DEO, Hyderabad and Commissioner, GHMC, Addl. CsP, Law & Order, Head Quarters & Training, Zonal jurisdictional DCsP (L&O and Traffic), DCsP Special Branch, CSW, Addl. DCP, CAR Head Quarters, concerned Sub Nodal ACsP, divisional ACsP & SHOs conducted a Joint inspection of DRC (Distribution, Reception and Counting Centres) of 08-Secunderabad PC including Secunderabad Cantonment (as part of Malkajgiri PC) and 71-Secunderabad Cantonment (Bye election) and reviewed the Security Arrangements at the DRC Centers/Strong Rooms.

Further, also from 03.00 PM onwards CP, Hyderabad along with the above said officials conducted a Joint Inspection of DRC (Distribution, Reception and Counting Centres) and Voter Facilitation Centre i.e., All Saints High School, Gunfoundry, Abids, Hyderabad for Postal Ballots of 09-Hyderabad PC and reviewed the security arrangements.

During the joint inspection the arrangements related to L&O and traffic pertaining to the distribution, reception were reviewed. Further, the measures to be taken for three layer security as per ECI guidelines were also finalized to secure the strong rooms.
