RAID AT "AFTER 9 PUB" IN THE LIMITS OF BANJARA HILLS PS

The Commissioners Task Force, West Zone team along with local police acting on credible information raided one establishment Styled as **"AFTER 9 PUB"** in the limits of Banjara Hills police station in the night of 4/5th May 2024. It was found that the club management had hired women for the purpose of enticing male customers and they were indulging in indecent and obscene behavior in a public space. The management of the bar acted against the dignity of women and further sexually objectified them for the purpose of financial gain which is immoral and unethical. Further, D.J. music system was playing beyond permissible decibels of sound in the above pub by violating the prescribed rules. The management of the above **"AFTER 9 PUB"** have engaged the women to attract the customers with an intention to gain money in an illegal manner. Hence apprehended the following persons.

Recently, Commissioner's Task Force (North zone) have also raided on one Bar styled as Urvasi Bar and Restaurant at Begumpet wherein similarly management had hired women to engage in indecent behavior with customers. Legal Action was taken up against the establishment to ensure its closure. All the managements of Pubs and bars are hereby advised to ensure that their premises are run legally and to not encourage any obscene and illegal activities. Going forward as well, all such establishments will be monitored and strict action will be initiated in case of any deviation.

ARREST OF ACCUSED IN JOB FRAUD

Hyderabad Cyber Crime Police arrested one accused person from Bangalore, Karnataka by name S Mahesh R/o Doddabellapura, Bangalore who is involved in Job Fraud. During the investigation it is found the accused was involved in 16 other cases across the country and more cases to be identified during the course of further investigation.

CASE FACTS:-

Complaint received from victim R/o Yousufguda, Hyderabad stating that he saw job advertisement in telegram and contacted the accused person. The accused person in the name of providing Job in MNC Companies cheated complainant and his seven other friends total to the tune of Rs 46,19,000/-. Cyber Crime Police, Hyderabad registered a case in Cr.No.2570/2023 U/s 66(C)(D) IT Act, 419, 420 IPC and investigated in to.

MODUS OPERANDI OF ACCUSED:

The accused person used to post ads of job opportunities in the MNC companies through social media platforms and by seeing the ads unemployed youth will contact the accused person. Accused person conducted interviews and issued appointment letters by taking huge amounts and cheat them. When victims approached the companies then they came to know that they are cheated.

SEIZURE:-

The team headed by Inspector of Police Sri. K. Madhusudhan Rao consisting of team members Sri SI Mahipal Sri Suneel, PC, Sri B.Bhasker PC 9527, & Sri B.Sandeep PC 4658 under the direct supervision of Sri Chand Basha, ACP, Cyber Crime PS, Hyderabad has cracked the said case at Bangalore.
