THE SLEUTHS OF KULSUMPURA POLICE ARRESTED NOTORIOUS HABITUAL OFFENDERS OF ROBBERY & SNATCHING CASES & DETECTED (06) PROPERTY OFFENCES IN HYDERABAD & CYBERABAD COMMISSIONERATES.

**Cr.No.345/2024 U/s.309 (4) , r /w 3(5) of BNS,
Sec. 25(1)(A), 25(B) of I.A.Act-1959 & Sec.106 BNSS, of Kulsumpura PS.**

This is the case of "Robbery", occurred on 24-12-2024 at 04:30 hrs, At 100ft road, Puranapool, Hyderabad. Wherein, complainant Sri. R.Krishna, Age: 33 years, Occ: Labour, R/o Mahesh Nagar Colony, Gudimalkapur, Hyderabad, on 24-12-2024 at about 04:30 hrs, while the complainant was returning from work to his residence on his two wheeler Glamour bearing number TS13EN9614, when he reached at 100 feet road, meantime 3 persons came on a two wheeler and threatened him with dire consequences to give his mobile and vehicle keys as it was isolated place, the persons forcibly took away his mobile Oppo A55 and his vehicle Keys. After taking his mobile and vehicle keys, three persons fled away from there.

They also wanted in Attempt to Murder Cases of PS Attapur and House Trespass and trying to Extortion Case of PS Langer House.

SOUTH ZONE TASK FORCE APPREHENDED ONE CCL WHO COMMITTED THEFT OF GOLD, SILVER ORNAMENTS AND OTHER OBJECTS BY ENTERING INTO THE HOUSE –SEIZED- GOLD & SILVER ORNAMENTS ETC., ALL W.Rs. 3 LAKHS

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Hussaini Alam Police on credible information apprehended (01) CCL who committed theft of gold and silver ornaments by entering into the house under the limits of Hussaini Alam Police Station.

Details of the accused persons:-

- **CCL**, aged about 17 yrs, R/o 1st Lancer, Hyderabad.

Seized Objects:-

- Gold and silver ornaments weighing about 85 grams
- Net cash of Rs. 6,200/-
- Cell Phones – 02
- And other objects
- **All W.Rs. 3 Lakhs.**

Brief facts of the case:-

The CCL is born and brought-up from Hyderabad. He is studied upto 3rd standard. Later, he did not pay much attention to his studies and addicted to illegal activities. In this juncture he committed theft of (02) two wheeler vehicles and (01) Cell Phone under the limits of Hyderabad City Police. Further, he addicted to lead lavish life, for which he did not have sufficient amount. In this regard, he hatched a plan to commit property offences to meet his lavish desires. Upon which he came to Hussaini Alam area and committed theft of gold, silver ornaments, cell phones and some amount by entering into the locked house in the absence of inmates.

Basing on credible information, the Commissioner's Task Force, South Zone Team, Hyderabad along with Hussaini Alam Police have apprehended the said CCL and seized the above said objects at his instance and handed over to Hussaini Alam Police for further investigation. The SHO, Hussaini Alam Police Station registered a case in Cr. No. 236/2024, U/s 305 BNS and took up investigation.
