BUSTED A CELL PHONE SNATCHING/THEFT GANG CONSISTING OF (06) ACCUSED INCLUDING (02) RECEIVERS – SEIZED - 08 CELL PHONES, 01 KNIFE, 01 AUTO RICKSHAW - ALL W.Rs. 3,00,000/-

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Hussaini Alam and IS Sadan Police have apprehended (06) accused persons including (02) receivers and detected (05) cases in the limits of Hyderabad and Rachakonda Police Commissionerates.

DETAILS OF ACCUSED PERSONS:-

1. **Md. Abbas Ali @ Chor Abbas, @ Loud Abbas**, age.60 yrs, Occ: Fruit vendor, R/o Shaheen Nagar, Hyderabad (**Rowdy Sheeter of Hussaini Alam PS**)
2. **Mohd Rizwan**, age : 24 yrs, Occ: Labour R/o Shaheen Nagar, Balapur
3. **Mohd Sadiq @ Chota Moosa**, age : 22 yrs, Occ: Labour, R/o Bhvani Nagar, ar, Hyderabad
4. **Mohd Dastagiri**, age.48 yrs, Occ: Auto Driver, R/o Kanchanbagh, Hyderabad
5. **Mohd Sattar**, age : 28 yrs, Occ: Cook, R/o Balapur, Hyderabad (**Receiver**)
6. **Shaik Azher @ Azzu**, age : 30 yrs, Occ: Decoration Work, R/o Rein Bazar, Hyderabad (**Receiver**)

BRIEF FACTS:-

All the accused are born and brought up from Hyderabad. The prime accused **Mohd Abbas Ali @ Chore Abbas @ Loud Abbas** is having criminal back ground and involved as many as (37) cases in property, bodily and other offences. He is started to commit offences since 1989. He is popularly known as **Chore Abbas @ Loud Abbas**. Further, he is doing his livelihood by profession as fruit vendor. In this business, his earnings are not sufficient to lead his family members and his lavish life. In these circumstances, he hatched a plan to commit snatchings/theft of cell phones from the public in huge gatherings at business places. In this juncture, he made a gang with the accused persons **1) Mohd Rizwan, 2) Mohd Sadiq @ Chota Moosa, 3) Mohd Dastagir**. As per their plan, they used to move in large crowd places and diverting their attention to commit snatching/theft of cell phones from their pant/shirt packets without their knowledge, if anybody objects them, they will show the knife. In this juncture, they committed offences in the limits of Hyderabad and Rachakonda Police Commissionerates. Later, the stolen booty will dispose by handing over to the cell phone receivers 1) **Mohd Sattar and Shaik Azher** and earning money illegally.

Basing on credible information, the Commissioner's Task Force, South Zone Team, Hyderabad along with Hussaini Alam and IS Sadan Police have apprehended the above said accused persons and seized **08** Cell Phones, **01** Knife and **01** Auto Rickshaw at their instance and handed over to Hussaini Alam/IS Sadan Police Stations for further investigation.
