**NOTIFICATION**

Biennial Election to Telangana Legislative Council - Hyderabad Local Authorities Constituency, 2025 are scheduled to be held in Hyderabad Poll day on 23-04-2025 and Counting of Votes on 25-04-2025.

After reviewing the situation carefully and with a view to maintain public order, peace and tranquility in the twin cities of Hyderabad and Secunderabad in the last **48 hours before the closure of Polling on 23-04-2025**, I, C.V.Anand, IPS., Commissioner of Police, Hyderabad City in exercise of the power conferred on me under section 22 (1) (d) to(f) and 22 (2) (a) to (e) and 22 (3) of the Hyderabad City Police Act, do hereby issue the following prohibitory orders:-

1. Prohibit assembly of more than 5 persons and any kind of processions.
2. Prohibit carrying of sticks either with or without flags, lathies, fire arms, or any other weapons which can be used as weapons for offence or defence by persons in processions, big gathering or meetings within a radius of one K.M from the polling stations.
3. Prohibit erection of temporary structures like Shamianas, Pandals, Khannath etc., on thoroughfares, public places and all other places where public may throng.
4. Prohibit use of mikes/public address system by anybody or parties in the entire twin cities of Hyderabad and Secunderabad.
5. Prohibit music, singing or speeches or broadcasting through speakers or any other instruments.
6. Prohibit collection, carrying of stones and other means of casting missiles.
7. Prohibit making a speech, gesture or mimetic representation, exhibition or dissemination of pictures, symbols, placards or any other thing which is likely to create religious animosity or hatred between different communities or individuals or is likely to bring about commission of an offence of disturbance to or contempt of the law or of a lawful authority.

The following are exempted from the operation of this order:-

- a) Police Officers (including Home Guards and SPOs) on duty.
- b) Military/Para Military personnel on duty.
- c) Election Officers on duty.

However, it is clarified that this does not restrict house-to-house visits, of more than 5 persons, during the last 48 hours period ending with the hour fixed for the close of polls, in connection with door – to – door campaigning.

The public are hereby informed that any person violating the above orders shall be liable for prosecution.

This order shall be in force with effect from 1600 hours on 21-04-2025 to 0600 hours on 24-04-2025 and from 0600 hours on 25-04-2025 to 0600 hours on 26-04-2025.

**NOTIFICATION**

In exercise of the powers vested in me Under Section 20 Telangana Excise Act, 1968, (Act No.06 of (1794), I, C.V.Anand, IPS., Commissioner of Police, Hyderabad City, do hereby order in the interest of public peace and tranquility that no liquor shops, hotels, restaurants, clubs and other establishments selling/serving liquor, situated within the limits of the twin cities of Hyderabad and Secunderabad shall remain closed and not permitted to sell/serve liquor to anyone whosoever, **from 04.00 PM on 21-04-2025 to 04.00 PM on 23-04-2025 and from 0600 hrs on 25-04-2025 to 0600 hrs on 26-04-2025.** Non proprietary clubs, star hotels, restaurants etc., and hotels run by anyone even if they are issued different categories of licenses for possession and supply of liquor, shall also not be permitted to serve liquor on these days, in connection with Polling day and Counting of Votes for "Biennial Election to Telangana Legislative Council - Hyderabad Local Authorities Constituency, 2025" to be held in Hyderabad **on 23-04-2025 and 25.04.2025.**
