

PRESS NOTE

Hyderabad, May 22, 2025 – In preparation for the upcoming Bakrid festival, a coordination meeting was held today at the 5th Floor conference Hall of the Old Police Commissioner's Office, Basheer Bagh. The meeting, chaired by Hyderabad City Police Commissioner, Sri C.V. Anand IPS, aimed to ensure a peaceful and clean celebration of the festival across the city.

Sri Vikram Singh Mann IPS, Additional C.P., Law and Order, Shri R.V. Karnan IAS, GHMC Commissioner, Shri C. Ramesh, Joint Transport Commissioner, Mrs. Pankaja, Addl. Commissioner (Health), Sri. Raghu Prasad, Addl. Commissioner (Sanitation), Dr. CH. Malleshwari, Addl. Director (V&AH), DCP SB Cyberabad, DCP Crimes Rachakonda, DCP Rajendra Nagar, DCP Balanagar and DCPs, Additional DCPs, and Divisional ACPs from Hyderabad City Police Commissionerate were present in the meeting.

During the meeting, Sri C.V. Anand discussed on several important points:

- **Curbing Illegal Animal Transportation:** He instructed the establishment of checkpoints around the Hyderabad City Commissionerate to prevent the illegal transportation of animals without proper veterinary certificates or those not ready for slaughter. Vehicles found violating these rules are to be seized and immediately sent to GHMC-designated animal holding points or goshalas. The Commissioner appealed to the public and Gorakshak members not to take the law into their own hands, emphasizing that only government officials and law enforcement agencies are authorized to stop or inspect vehicles carrying animals.
- **Veterinary Services:** The Animal Husbandry Department and GHMC were requested to ensure the availability of 24/7 veterinary doctors at all check posts.
 - o GHMC officials were advised to deploy dog catching squads in all areas before Bakrid to manage stray dogs.
 - o They were also instructed to supply disposal covers to every household for the disposal of animal carcasses.
 - o Special teams are to be deployed on the festival day for the collection of garbage and carcasses.
 - o GHMC is to arrange adequate vehicles, tippers, and JCBs for efficient collection and disposal of animal waste, and ensure sufficient staff for waste removal during Bakrid.
- **The Electricity and Engineering departments** were directed to ensure uninterrupted power supply during the festival to prevent any inconvenience to the public.
 - o HMWSSB and Engineering officials are to supervise and maintain sewerage systems and ensure uninterrupted water supply.
 - o RTA officials were asked to ensure the availability of sufficient drivers, mechanics, and cranes.

The GHMC Commissioner detailed the extensive sanitation measures being implemented, including the deployment of additional sanitation teams and garbage collection vehicles near wards and mosques. He assured that garbage bags would be readily available and GHMC officials would be actively performing their duties.

Sri C.V. Anand IPS reiterated that only assigned police personnel, GHMC, and Animal Husbandry Department staff would be present at the checkpoints. He suggested forming local, zonal, and commissionerate-level coordination teams comprising officials from all departments for better coordination and response. He concluded by stating that this coordinated mechanism, through continuous collaboration and proactive actions by officials, would significantly help in resolving any issues that may arise, ensuring a smooth, safe, and joyful Bakrid celebration for all citizens.

PRESS NOTE ON SOCIAL MEDIA FRAUD

The Hyderabad Cyber Crime Police have arrested one accused from Narsannapeta Village and Mandal, Srikakulam District, Andhra Pradesh, for involvement in a case of impersonation. The case has been registered in Cr. No. 900/2025, U/s 66C, 66D of the IT Act, and Section 319(2) of the BNS by the Cyber Crime Unit, Hyderabad.

The accused had created fake email ID reventhreddyosd@gmail.com and sent fraudulent emails to various business persons while impersonating the Personal Secretary and Officer on Special Duty (OSD) to the Hon'ble Chief Minister of Telangana State. He is involved in 13 cases in Telangana State and 16 cases in Andhra Pradesh State. Additionally, a Non-Bailable Warrant (NBW) is pending against him in the XII ACMM Court, Nampally, in Cr. No. 94/2020 of CCPS, Hyderabad, with CC No. 9309/2020.

CASE FACTS:

Received a complaint from OSD to CM of Telangana regarding fake mail id's and WhatsApp calls, certain individual with Mobile number 9666349191, who falsely claimed complainant's identity as Personal Secretary & Officer on Special Duty to the Chief Minister of Telangana State. Amongst others, in a latest incident, the offender with the above mobile number had reached out to Mr. Krishna Mohan Bollineni, MD Bollineni Infra Projects via the email address reventhreddyosd@gmail.com. On multiple occasions in the past, it has come to their attention that the accused had contacted various individuals via Email, WhatsApp, and Phone Calls, which includes Mr Aravind Sanka, MD of Rapido, Mr Srinivas Gupta Verrabomma, Chairman of Gupta Realty, Mr Krishna Mohan Bollineni, MD of Bekem Infra Projects Pvt. Ltd, Sri Chakradhar & Nitin Koushal, MD of Country delight, and several others in an effort to solicit financial assistance.

MODUS OPERANDI:

The accused create fake email id and WhatsApp account with mail id of persons who are in high position in government and sends mails, Messages, WhatsApp calls to persons who are rich and holding different businesses, companies and are highly reputed in the society, in an effort to solicit financial assistance.

SEIZURE OF PROPERTY:

1. Mobile Phone : 1

The team headed by the Inspector of Police Sri S, Mattam Raju, consisting of team members SI's A Shailendra Kumar, K Hima Reddy and PC's P Ashok and K Ajay Kumar have cracked the case.

Public are cautioned, not to believe the messages or mails received from high level designated government official and asking money in Social media platforms.

This is a case of Robbery occurred on 17.01.2025 from 1430 hours to 18.01.2025 till 0200 hours from Sri Sai bar Chikkadpally to Mehdipatnam, Hyderabad detected by Chikkadpally police on 22-05-2025 with the help of CCTV footages and on credible information apprehended the accused Lady Kontham Sony @ Shahanaz Begum @ Rosy and recovered case property. Then accused lady was arrested and producing her before Hon'ble IXth ACJM, Nampally with a request to send the accused lady for judicial custody on 22-05-2025 in Cr.no.19/2025 U/s 309 (4) BNS of PS Chikkadpally.

Property Lost:

Rs. 20,000/- cash, Infinix mobile, Gold Ear studs weighing about 5 grams Gold Ear Mateelu weighing about 5 grams, silver anklets weighing about 300 grams, ATM, ESI card and house and almariah keys.

Brief fact of case:

On 18.01.2025 at 1300 hrs received a complaint from Smt. M. Satyamma, W/o Mallesh (Late), A/50 years, Occ: GHMC Sweeper, R/o Mahatma Nagar Colony, Musheerabad. Wherein she stated that on 17.01.2025 accused lady has taken her from Sri Sai bar Chikkadpally toddy compound, she makes her to drink toddy and forcibly taken Rs. 20,000/-, her Infinix mobile, her ear studs weighing about 5 grams, and Ear Mateelu weighing about 5 grams, silver Anklets weighing about 300 grams, ATM, ESI card, house and almariah keys, dropped her at Mehdipatnam.

We made efforts to trace out the accused person, formed the team by DI M Shankar with L Mounika SI of police with crime team, verified the nearly 50 CC Camera's from Chikkadpally to Mehdipatnam, enquired the suspects persons, MO Offenders various aspects, verified locals and detected the robbery case and apprehended the accused lady and recovered following properties:

So far total property recovered from Kontham Sony @ Shahanaz Begum @ Rosy.

One pair of gold ear stud weighing about 3.620 Grams.

One pairs of gold Mateelu weighing about 2.780 Grams.

One pair Silver Anklets weighing about 237.700 Grams.

Cash 5500/- (500*11=5500 denomination)
