### **SHE Teams Conducts Counselling Session for 289 Individuals Caught in Acts of Harassment Against Women**

**Hyderabad, 23rd May 2025** – A counselling session was organized by **SHE Teams, Women Safety Wing Hyderabad** in collaboration with **Manojagruthi NGO**, aimed at sensitizing individuals apprehended for acts of harassment against women during the period from **January to April 2025**.

A total of **304 individuals** participated in the session, including **289 respondents** (comprising **271 majors** and **18 minors**) and **15 parents/guardians** of the minors.

The session was conducted by a team of professional psychiatrists from Manojagruthi, including **Dr. Geetha Challa, Kairi Thrinath Goud, Swathina Shasi, S. Srilatha, Syed Abeeda Begum**, and others professionals. The focus of the counselling was on **behavioral correction, legal awareness**, and promoting **respectful and lawful conduct** in public spaces.

**Smt. Dr. Lavanya NJP, DCP, Women Safety Wing Hyderabad**, addressed the gathering during the counselling session and highlighted several key points. She emphasized that **consumption of alcohol, drugs, and smoking** can significantly affect **behavior and emotional control**, often leading to regrettable actions. She also cautioned that **associating with friend who engage in bad habits** can have serious consequences, urging the attendees to **choose their companions wisely**. Additionally, she spoke about the concept of **delayed gratification**, narrating a short story to illustrate its importance, and explained how **patience and self-control** can lead to more meaningful and long-term success in life.

Some of the respondents voluntarily shared their reflections during the session, expressing **guilt** for their actions. They spoke about the **impact their behavior had on their families and friends**, and how it affected their relationships. They also **appreciated and thanked SHE Teams** for organizing such counselling sessions, acknowledging its role in creating awareness and offering them a chance to **reflect, reform, and make better choices**.

This initiative underscores SHE Teams' commitment not only to law enforcement but also to **rehabilitation, reformation**, and **community awareness**, developing a safer and more respectful environment for women in Hyderabad.

#### **NABBED TWO ACCUSED – SEIZED – 13.43 GRAMS OF GOLD ORNAMENTS, 37.64 GRAMS OF SILVER ORNAMENTS & 02 CELL PHONES- ALL W.RS. 1.6 LAKHS APPROXIMATELY.**

The sleuths of Commissioner's Task Force, South Zone Team, Hyderabad along with Shahalibanda Police have apprehended two accused persons who entered into the house by breaking the house lock and committed theft of gold and silver ornaments from the almirah.

#### **Brief facts:-**

The above said accused persons are born and brought up from Hyderabad and they are close friends. Their earnings are not sufficient to lead their families and they have addicted to bad vices. In this juncture, they both hatched a plan to commit property offences to fulfil their desires. Accordingly, the accused **Abdul Wasi** selected one of his relative's house situated at Shahalibanda. For that, Wasi conducted recce along with his friend **Mohd Abdul Waheed** and committed theft of gold and silver ornaments by broke open the main door and almirah locks by using iron rod and sped away with the stolen booty. Later, some stolen gold ornaments pledged in Muthoot Finance, Falaknuma and taken amount. The accused **Abdul Wasi** is also having previous criminal background vide Cr. No. 371/2004, U/s 454/380 IPC of Mancherla Town PS. Further, on 19.05.2025 basing on the complaint of Sri Mohd Khaled, R/o Shahalibanda the Shahalibanda Police registered a case in Cr. No. 66/2025, U/s 305, 331(3) of BNS and took up investigation.

On tip of information, the Commissioner's Task Force, South Zone Team, Hyderabad along with Shahlibanda Police have apprehended the above said accused persons and recovered the stolen property at their instance. The apprehended accused persons and seized material handed over to the SHO, Shahalibanda PS for further investigation.

LANGER HOUSE POLICE ARRESTED BIKE THEFT OFFENDER

**FACTS:**

**CLUES:**

On 23.05.2025 at around 09:00 PM, SI Raghavendra, along with the Crime Staff, was patrolling near Bapughat, close to the Ramalayam Temple. During the patrol, they noticed a person moving suspiciously. When they questioned him, he tried to escape from the spot. However, with the help of the Crime Staff, he was caught at a short distance and brought to the police station. Some of his main operating spots include the Bapu Ghat Bus Stop and other busy public places where people often leave their vehicles unattended.

#### **("PSEUDO-POLICE")**

Based on credible information, the sleuths of the Commissioner's Task Force, West Zone Team, along with Musheerabad police apprehended an individual who is impersonating as a forest beat officer or Police officer and fraudulently collecting money from people by promising them government jobs.

#### ➤ **BRIEF ABOUT CASE:**

During the investigation, the accused, K Kiran Kumar, confessed to impersonating as a Forest Department Beat Officer or as Police constable. He was found patrolling public areas while wearing a police uniform and riding a

Hero Glamour motorcycle bearing the word "POLICE" and equipped with a siren, thereby misleading the public by projecting a false sense of authority.

Kiran Kumar further admitted to acting as a mediator, fraudulently promising government jobs in exchange for money from unsuspecting youth. He collected money from victims identified as J. Subash, Kumar and Ashiwini under the Pretext of securing employment in government services. He also obtained original documents from J. Subash by posing as a police officer. The accused continued to deceive and extort money from other individuals through similar fraudulent schemes, misrepresenting himself as a government official. In this way the accused Kiran has cheated 05 innocents on the pretext of providing jobs and duped them to a tune of Rs 20,00,000/-.

The accused has a known criminal history and is involved in multiple cases if cheating across various districts:
