COMMISSIONER'S TASK FORCE BUSTED PROSTITUTION RACKET IN HYDERABAD

Based on the credible information, the sleuths of Commissioner's Task Force, West Team Zone along with the Banjara Hills Police raided on a Brothal house in the limits of Banjara Hills PS and apprehended (01) Organizer (02) Housekeeping staff (03) Customers and rescued (04) Female workers.

Details of the Accused:

- 2) Anand Kumar S/o Lal Babu age 30 occ: housekeeping at brothel house R/o sahu, Muzaffarpur, Ram Nagar, Bihar (Housekeeping Staff)
- 3) Rahul kumar s/o Lal Babu sah age 26 occ servant at brothel house R/o Ramnagar, muaffarpur, Bihar (Housekeeping Staff)

Brief about the case:

On 10-06-2025 at about 2130 hours, the sleuths of the Commissioner's Task Force, West Zone Team, along with the Banjara Hills Police, conducted a raid on a brothel house located at the above-mentioned address, which falls under the jurisdiction of Banjara Hills Police Station, and apprehended one person, by name Kummeta Narender Reddy (Organizer of the brothel house). He had been running the brothel house with the involvement of four (04) female workers. The organizer used to contact both the customers and the sex workers to facilitate their sexual activities and charged the customers around ₹4,000 to ₹5,000 per person. He used to pay the sex workers a fixed salary for their services. Further, the police apprehended three (03) customers and rescued four (04) female workers from the premises.
