NATORIOUS HOUSE BURGERLY GANG ARRESTED IN JOINT OPERATION BY NARAYANGUDA POLICE EAST ZONE AND EAST ZONE TASK FORCE TEAM AND RECOVERED STOLEN PROPERTY WORTH RUPEES 1.7 CRORES.

The Sleths of Narayanguda Police of East Zone and commissioner Task force Team East Zone in a joint operation arrested notorious criminals HB offenders.

The offenders committed House Burglary on the intervening night of 05/06-06-2025 in the limits of Narayanguda and stolen away Gold ornaments, Cash and some costly watches.

A-7) Chandra Shekar Chaupal, S/o Kapileshwar Chaupal, age: 49 yrs, Occ: Business, R/o 13-5-292/A Amlapur, Talla gadda, Asif Nagar, Hyderabad. (**Receiver of stolen property**)

Modus Operandi :

The offender A-1 decided to commit theft in the house at Avanthinagar, Basheerbagh where his mother in law is working as maid servant and hatched a plan of committing of theft and conspired with the other accused A2 to A6 in the absence of family members.

Brief Facts of the Case:-

Cr.No. 164/2025 Us 331 (4), 305 BNS of PS Narayanguda, Hyd.

On 07.06.2025 at 2330 hrs received a complaint from Sri. Nukala Rama Krishna S/o N. Om Prakash, age: 42 yrs, Occ: Business, R/o Plot no: 42, Avanthinagar, Basheerbagh, Hyd. Stating that total around 173 Tulas Gold ornaments, Watches and net cash 17,50,000/- which was kept in the safety locker were stolen by unknown offender by gaining entry into the house by removing the window grill in their absence,. Hence he requested to take necessary action and recover the stolen jewelry and cash as early as possible. Based on above complaint, a case in crime no: 164/2025 Us 331 (4), 305 BNS was registered at PS Narayanguda and investigated into.

As per the instructions of CP Hyderabad City, DCP East zone, special teams have been formed under the charge of Addl. DCP East zone, Addl DCP task force and ACP Sultanbazar. The Teams consisting Sri: U. Chandrashekar SHO Narayanguda, DI. Nagarjuna and DSI along with crime Staff and another team consisting Sri: Nagarjuna Insp East zone Task force played vital roles by viewing the CCTV Cameras and by using the technology and apprehended the above four offenders in this case at Kummarwadi, Asifnagar on i.e 16-06-2025 at 18:00 hrs who were about to escape from Hyderabad as per their plan.

The offenders were thoroughly interrogated and recovered the stolen booty from their possession and the details of the recovered property is as follows

“The current value of the recovered property is worth about 1.7 Crores.”

BOWENPALLY POLICE ARRESTED THREE ACCUSED PERSONS OF DIVERTING ATTENTION GANG; RECOVERED 77 ANDROID MOBILE PHONES AND TWO-WHEELER VEHICLES (2), TOTAL WORTH ₹25,00,000/-

Sleuths of Bowenpally Police, yesterday i.e., 16-06-2025 apprehended three members of diverting & attention gang and recovered 77 Android cell phones & two '2'-wheeler vehicles **All WORTH TWENTY-FIVE LAKHS RUPEES ONLY.**

DETAILS OF THE ACCUSED PERSONS

A-1) Ganta Chinna @ Chinna S/o Late Ganta Chinna Appa Rao, age 40 yrs, Caste. Yerukula (ST), Occ. Auto driver, R/o Flat.No.223, Beside Ladies Hostel, Opposite to Sai Baba Temple, Dilsuknagar, Hyderabad, N/o Near Indian Bank, Saturday market, Purbakote Village, Jajpur Dist, Odisha State.

A-2 Pradhan Srikanth S/o Pradhan Jagannatha, age 22 yrs, Caste. Snake Charming Tribes, Occ. Labour work, R/o Housing Board, Mallapur, Hyderabad, N/o Dasamania Village, Jakhapura Station, Jajpur Dist, Odisha State.

A-3 Avula Gopi Rao @ Gopi S/o Late Bola Rao, age 20 yrs, Caste. Snake Charming Tribes, Occ. Labour work, R/o Housing Board, Mallapur, Hyderabad, N/o Kantira, Rugodi Village, Rudrapur Gram Panchayat, Jajpur Dist, Odisha State.

A-4) Jagir - Receiver (Absconding)

(Involved in Crime Nos. 265/2025, 266/2025, 267/2025 and 268/2025 of PS Bowenpally & 07 Other cases at Miyapur, Attapur, Medchal, Bachupally, Chandanagar, Narsingi, Police Stations of Cyberabad Commissionerate)

Property Recovered: Total 77 Android cell phones & Two '2'-wheeler vehicles.

Brief Facts of the Case:

On 13.06.2025 at 1200 hours, Complainant Sri Kola Raja Narsimha, R/o Peerzadiguda, Uppal, lodged a complaint stating that on 05.06.2025 at 1330 hours, while crossing Tadbund signal, he tried to help an unknown person who was lying near a bike. Meanwhile, another person diverted his attention by pretending to be injured and stole his Realme C53 Android cell phone (Black, Ph: 9966008601). Both fled the scene on the bike. He requested to take necessary action as per law.

Bowenpally Crime team made efforts and verified more than 250 CC Cameras to identify the accused persons.

On **16-06-2025**, during the **morning hours**, while conducting the vehicle checking at **Tadbund Chowrastha at Bowenpally**, **three accused persons** were apprehended along with **two bikes without number plates**. During the interrogation recovered 77 Android cell phones & two bikes.
