While he was working in Katedan, he met **Pawan Bhati @ Raja (Transporter)** who told him about the sale of Meow Meow (MD) and they both mutually agreed to sell the drug in Hyderabad to the needy customers. He procured the drug at lower price and selling to the need customers at a higher price with intent to earn easy money.

Further, he also procured a country made pistol worth Rs. 70,000/- along with (07) live rounds in which (01) round, he made test fire in Katedan area.

**Pawan Bhati @ Raja** born and brought up in Rajasthan. His father is vegetable seller, he studied up to Intermediate. Soon after completing his Intermediate he came to Hyderabad and started a Kirana shop as a partner along with relatives. After running the shop for 2 years, he exits from the partnership due to losses. Soon after, he started an own sweet shop at Uppuguda in the year 2021 which also shut down due to heavy losses. Thereafter, he went to his native place and worked there as driver for some time. In month of May 2025, he came to Hyderabad and setup a Juice bandi during the summer season. After that he felt no work with him, so he went to Rajasthan and procured Meow-Meow (MD) from Surrender, R/o.Nagur, Rajasthan and delivered to **Jeetendara panwar @ Jithu** for selling.

**Hemsingh Kachhawa @ Hemu**, who resides in Rajasthan, upon the instructions of the **Jeetendara panwar @ Jithu** he procured Meow-Meow (MD) from Rajasthan and delivered to Jithu and getting commission. He was recently got released from jail as he was arrested by Nagaur Women PS in POCSO vide Cr.No.67/2021, U/s. 323, 376, 511 IPC & Sec.11, 12, of POCSO Act 2012, Sec. 3W(ii) of SC & ST Act 1989.
