### **'Operation Kavach' Concludes Successfully in Hyderabad: 5,000 Police Personnel Deployed**

The Hyderabad City Police's prestigious 'Nakabandi' (cordon and search operation), codenamed **'Operation Kavach'**, aimed at maintaining law and order, has been successfully concluded. The operation was conducted simultaneously on Friday night across **150 locations** in the city, involving **5,000 police personnel**. 'Operation Kavach' lasted from 10:30 PM until 1:00 AM.

Going beyond mere instructions, City Commissioner of Police, **Shri V.C. Sajjanar, IPS**, personally took to the field. He visited and directly supervised the inspections in sensitive and key areas such as **Tolichowki** and **Gulzar Houz** in the Old City, falling under the South West & South Zone, providing necessary instructions to the staff.

Subsequently, he reached the **'Telangana Integrated Command and Control Centre' (TGICCC)** in Banjara Hills, from where he monitored the city-wide inspections via CC cameras. He also spoke with Joint CP (Law and Order) Sri **Tafseer Iqubal IPS** and other SHO (Station House Officers) to inquire about the operation's progress.

This special drive was conducted with the coordination of **Law and Order Police**, along with the **Task Force, Traffic**, and **Armed Reserve** forces. Every vehicle was thoroughly inspected. Suspects were taken into custody, and several vehicles without proper documents were seized. Approximately **15,000 vehicles** were checked, and **1,600 vehicles** were seized. **Eight individuals** were taken into custody. As part of these inspections, half a kilogram of **Ganja (cannabis)** was recovered within the limits of Tukaram Gate. A total of **105 petty cases** were registered.

CP VC Sajjanar commended the professional commitment displayed by the staff during the operation. He clarified that this mega-drive was undertaken with the name **'Operation Kavach'** to make Hyderabad a crime-free city and to further enhance the sense of security among the public. He stated that those involved in illegal activities and those driving without proper documents will henceforth face strict action, emphasizing that there will be **no compromise on law and order**.

He also informed that this operation will not stop in a single day, and **surprise inspections will continue constantly** in the future. He specially appreciated the **5,000 police personnel** who performed their duties with dedication during the late-night hours.

Hyderabad Police Commissioner Sri V.C. Sajjanar, IPS, stated that **Home Guards are playing a crucial role** in maintaining law and order in the city, performing duties on par with the police personnel. He announced that a **special 'Home Guard Co-operative Society'** will soon be established under the City Police Department for their welfare.

On Saturday, the **Home Guards Raising Day** celebrations were grandly organized by the City Police at the CAR Headquarters in Petlaburj. CP VC Sajjanar, IPS who attended the event as the Chief Guest, inspected the parade and received the guard of honour.

Speaking on the occasion, the CP Hyderabad praised the dedication of approximately **5,000 Home Guards** working in the city. He mentioned that **2,000 people have already joined** the proposed Co-operative Society for Home Guards and advised the rest to also take up membership.

He reminded that the government is considering the matter of **sanctioning double-bedroom houses** to eligible Home Guards. The Commissioner of Police strictly advised every Home Guard to **compulsorily renew their driving license**. He explained that failure to renew the license could lead to difficulties in sanctioning insurance in case of road accidents.

He clarified that **strict legal action** would be taken against those who show negligence in duty or indulge in corruption and illegal activities. He asked them to maintain discipline and bring a good name to the Police Department.

Subsequently, commendation certificates were presented to those who displayed the best performance in the parade, as well as **25 individuals** who showed excellence in duty. **Ex-gratia cheques** were distributed to the families of **18 Home Guards** who passed away while on duty or due to other reasons.

**DCP (CAR) Hqtrs Smt Rakshita Krishnamurthy, Home Guards Commandant Sri NV Kishan Rao, and other senior police officials participated in the program.**

## **SERVANT THEF CASE, ONE FEMALE ACCUSED WAS APPREHENDED AND RECOVERED FOUR AND HALF TULAS OF GOLD ORNAMENTS TOTAL PROPERTY WORTH OF RS 5,00,000/- BY TOLICHOWKI PS**

On 06-12-2025 the sleuths of the Tolichowki PS, Hyderabad detected a Servant theft case and apprehended one offender with intact Recovery.

### **Cr.No: 249/2025 U/s 306 BNS**

**GIST:-** On 04-12-2025 at 2100 hrs received a complaint from Sri Iqbal Ahmed S/o Iftekhhar Ahmed Khan, R/o Flat No: 1008, D-Block, Satva Magnus, Tolichowki, Hyderabad. in which he stated that on 04-12-2025 at about 05:00 PM, his wife by name Raana Tabassum, informed him that while she was preparing for a family function, she noticed that her gold ornaments I.e.1) one gold chain with pendant, 2) one pair of gold ear rings, 3) one piece of gold ear ring, 4) one gold ring with diamond and 5) four gold bangles, total weight about 45 grams were missing from her ward room cupboard. Based on the complaint registered a case in Cr no: 249/2025 and while working out for clues, today i.e, on 06-12-2025 at about 0800 hrs received credible information about suspicious movements of a lady in tolichowki area. Immediately the Tolichowki Police visited the spot i.e. at OM Jewellers, tolichowki and verified the lady and found gold ornaments in her purse, but she did not discharged anything about gold. On investigation she confessed that she work as housemaid at Complainant residence past few months, had committed servant theft said gold ornaments to earn easy money.
