With reference to the subject cited above, it is submitted that on the complaint of Sri S Srinivas Rao and others, dated 14-03-2014, a case was registered against accused persons i.e., Smt Battula Vijaya Rani and others vide 1st reference cited, wherein the alleged accused persons A-1 in associate with A-2 to A-7 with un-registered financial establishment i.e., Chit Business collected huge amounts from depositors and defaulted to return the deposits and maturity amount to the depositors, despite the maturity period having expired. This failure has caused significant financial hardship to the affected depositors. Despite repeated requests, the establishment has failed to make the repayments thereby violating the terms under which deposits were accepted approximately for an amount of Rs.5.4 crores.

During the course of investigation, the investigation officer of this case identified certain Immovable / Immovable properties and send proposal to government for attachment and got ad-Interim orders from the Government of Telangana vide 2<sup>nd</sup> reference cited, the details of properties are shown in Annexure-1 to V. Later the Hon'ble Special Court designated under The Telangana Protection of Depositors of Financial Establishments Act, 1999 made **ad-Interim orders of attachment absolute** for attaching the properties, vide reference 3<sup>rd</sup> cited.

In the above facts and circumstance, the kind officer is requested to pass instructions to concern for uploading Public Auction Notice for sell of attached properties i.e., Furniture, Electronic and other home appliances articles with Hyderabad City Police official web portal i.e., [www.hyderabadpolice.gov.in](http://www.hyderabadpolice.gov.in) for publishing the same for fair course of auction.

Public Auction of seized items i.e., Furniture items, Electronic Home Appliances and other Home Appliances were seized in Crime No.56/2014 U/sec 406, 420, 120 (b) r/w 34 IPC, Sec 3, 4, 5 of Prize Chits and Money Circulations Scheme (banning) Act, 1978 and Sec 5 of APPDFA Act, 1999 and Sec 11/30 of Chit Funds Act, 1982 of CCS DD, Hyderabad by the investigation officer of this case on 19-04-2014 & 22-04-2014. Later, in due process of law the same seized properties were attached as Absolute by the Hon'ble Special Court i.e., Sessions Judge at Nampally, Hyderabad designated and the Telangana Protection of Depositors of Financial Establishment Act, 1999 vide Cri.M.P.No. 219 of 2024, dated: 20.06.2025. After, attachment it is required to sell these properties to bring monetary relief to the victims/depositors in pursuance of orders vide Cri M P No.2842/2025 dated 18-08-2025.

**Place of Auction :**

In the premises of CCS - Malkahan located at Crimes & SIT office, beside Vijaya Diagnostic Centre, Himayath Nagar, Hyderabad.

**Date of Auction :**

On 12-09-2025 at 1200 hours.

**Date of Inspection of Auction properties :**

The prospective bidders may inspect the auctioned properties from 06-09-2025 to 11-09-2025 on all working days during office hours.

1) The above said seized Furniture items, Electronic Home Appliances and other Home Appliances shall be auctioned to the highest bidder on "**AS IS WHERE IS BASIS**". The reserve price for auction is Rs.23,172/-. The successful auction purchaser shall have to pay 100 % amount from successful Auction purchaser on the spot through cash/online/Cheque/Demand Draft payment.

2) The successful auction purchaser shall have to take the auctioned items, within (03) days positively at his own cost, which includes all extra charges if any.

3) The Chairman of the committee reserves the right to accept or reject any auction bid without assigning any reasons and the decision of the Competent Authority shall be final and binding in all matters relating to the auction.


